Sir,

In producing herewith two (02) accused persons namely (i) Bikash Choudhury (22 yrs) S/O Rabindra Choudhury of Methibari, Parijat Road, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Bishal Sha (25 yrs) S/O Ram Ratan Sha of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling under arrest along with the following articles under seizure viz :- (i) 09 (nine) numbers of filled domestic LPG indane Gas Cylinder each cylinder containing 14.2 kgs of LPG and (ii) 01 (one) empty small LPG Gas Cylinder styled as "Hamara Bajaj". I, ASI Biplab Kr Das of Pradhan Nagar PS, SPC do hereby lodge this complaint against the above noted two (02) arrested accused persons to the effect that today i.e. on 13.04.26 at 18.15 hrs I received a specific source information that two persons namely Bikash Choudhury and Bishal Sha are residing in the rented house of one Jyoti Gurung of Bishnumaya Path, Methibari, Salbari and they stored huge numbers of illegal gas cylinder in their rented house noted above. Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 802 Dt. 13.04.26 and informed the fact to you. As per your kind order and direction myself along with ASI Bikash Roy and force all of Pradhan Nagar PS left for Methibari, Salbari to verify the veracity of the information. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender. On the way to Methibari, Salbari I informed RT van officer SI Biswajit Biswas and requested him to come to Methibari, Salbari under PS- Pradhan Nagar, Dist. Darjeeling to accompany with us. At around 18.35 hrs we arrived at Methibari, Salbari under PS- Pradhan Nagar, Dist.- Darjeeling and I contacted with my source and being pointed by the source, I entered into the rented room of suspects and found that two persons were inside the room. On interrogation they disclosed their identity as noted above. On search their rented room the above noted articles are recovered from their rented room. On further interrogation they disclosed that they procured such domestic Gas Cylinder clandestinely from one of their suppliers and sale the same to their designated and selected customers of their wrongful gain. On demand they failed to produce any valid documents in respect of Gas Cylinder stored in their rented room. During physical enquiry it is found that both the accused persons namely (i) Bikash Choudhury (22 yrs) S/O Rabindra Choudhury of Methibari, Parijat Road, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Bishal Sha (25 yrs) S/O Ram Ratan Sha of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling procured the said gas cylinders an essential commodity and combustible in nature, clandestinely and stored the same, without any precautionary and safety measures.

From the above facts, it is evident that the above noted accused persons are involved in procuring of Gas Cylinder in fraudulent means, running illegal business and also kept the same inside the rooms without any precautionary and safety measures which is combustible in nature and endanger to human life and property. Subsequently, he used to sell the same in increased rate to their designed customers for their wrongful gain, contravening the norms of Essential Commodity Act, 1955. Accordingly, I seized the above noted articles from the joint possession of the above noted detained persons namely (i) Bikash Choudhury (22 yrs) S/O Rabindra Choudhury of Methibari, Parijat Road, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Bishal Sha (25 yrs) S/O Ram Ratan Sha of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling in presence of independent witnesses under proper seizure list and subsequently arrested them after observing all formalities. They were informed regarding ground of their arrest and issued copy of Memo of arrest and copy of ground of arrest to them. Further I informed their guardian regarding arrest of above mentioned two accused persons and also inform that both the accused persons will be forwarded before Ld ACJM, Siliguri on 14.03.26 morning. The entire process of search and seizure was made in between 19.05 hrs to 19.25 hrs under the coverage of videography as per norms of BNSS.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Bikash Choudhury (22 yrs) S/O Rabindra Choudhury of Methibari, Parijat Road, PS- Pradhan Nagar, Dist. Darjeeling and (ii) Bishal Sha (25 yrs) S/O Ram Ratan Sha of Salbari Bazar, PS- Pradhan Nagar, Dist. Darjeeling and arrange for its investigation.
