Subject: FIR against **Hari Roy & Md. Javed Ali** and their armed associates for offences of criminal trespass, attempt to murder, grievous assault, robbery, mischief causing damage, unlawful assembly, and criminal intimidation.

Respected Sir,

I, **Mandhan Shah**, son of Rajesh Shah, resident of Natun Para, Gossainpur, Bagdogra, being the duly **constituted attorney** of **Smt. Neelam Saria**, wife of Deepak Saria, resident of Sunny Tower, Sevoke Road, Siliguri, most respectfully yet with utmost urgency lodge this FIR against **(1) Hari Roy**, son of Faysingh Roy, resident of Uttar Ektiasal, P.O. Sevoke Road, P.S Bhaktinagar and **(2) Md. Javed Ali**, son of Hatim Javed, resident of Ward No. 6, Dangipara, Siliguri, District Darjeeling along with their armed associates, hired musclemen and goons, who in furtherance of a premeditated **criminal conspiracy** have been continuously attempting to illegally grab and forcibly take possession of my principal's lawfully owned landed property measuring 46.5 decimals appertaining to R.S Plot No:- 148 corresponding to L.R Plot No. 8 at Mouza Dabgram, L.R Sheet No. 53, District Jalpaiguri, duly recorded in L.R Khatian No. 324 and purchased through two registered deeds being Nos. 1643 and 1644 of 2003 over which my principal has absolute right, title and peaceful possession and which is protected by boundary wall and few tin shed security structures where one **Nepal Roy**, son of Nipen Roy, resident of Uttar Ektiasal, is lawfully deployed as security guard, and I state that despite repeated resistance the accused persons have been returning in a more aggressive and emboldened manner and on **12.04.2026** they formed an unlawful assembly, criminally trespassed into the said land, violently demolished substantial portions of the boundary wall, destroyed the tin shed structure duly evident from **CCTV footage** and the said accused persons armed who were carrying **deadly weapons including knife, hockey, ram daav and sword** launched a brutal, deliberate and life-threatening attack upon the said guard with clear intention to kill him, inflicting grievous injuries all over his body part causing serious injuries and committed robbery by forcibly snatching his wristwatch and cash of Rs. 8,000/- thereby creating terror and panic, requiring immediate medical treatment as substantiated by medical reports dated 12.04.2026, and further the accused persons have openly issued grave threats that if my principal or her representatives dare to visit the property they will be killed and that they will illegally grab the land at any cost, thereby creating an imminent and real threat to life, property and public order, and further be it mentioned here that along with the above named accused some female goons have also come to our land who have threatened us that they will falsely implicate us in false criminal cases and the acts of the accused persons clearly constitute serious cognizable offences including criminal trespass, mischief causing damage, robbery, grievous hurt, attempt to murder, unlawful assembly, criminal intimidation and criminal conspiracy, and in view of the gravity, repetition and escalation of these

criminal acts I most strongly and urgently call upon you to immediately register this FIR by setting criminal law into motion under stringent provisions of law, forthwith arrest all accused persons and their associates, deploy adequate police protection at the site to prevent illegal land grabbing, and take strict action to prevent recurrence, and I state that I am ready to produce all relevant documents including original sale deeds, land records, medical reports, photographs and other evidence, and I further place on record that any delay, negligence or inaction in this matter will directly result in further violence, irreparable loss and unlawful dispossession.
