With due respect, I, **SMT. SUMITA BHOWMICK ROY**, D/o Late .
Kiran Chandra Roy, resident of Bankim Nagar, Ward No. 41 S.M.C.,
P.O. Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri in the State of
West Bengal would like to lodge this Written Complaint before your
good Office against my neighbor namely **1) SRI ALOK MANDAL**, Son of
Gopinath Mandal, along with his wife namely **2) SMT. MITA MANDAL**,
W/o Alok Mandal resident of Bankim Nagar, Ward No. 41 S.M.C., P.O.
Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri.

Sir, I had earlier filed an FIR against the above mentioned
persons on 01/01/2019 as they had assaulted me badly and I had
sustained severe injuries on my body and outraged my modesty and
the said case is presently sub-judice before the Learned Judicial
Magistrate 2nd Court at Jalpaiguri. Since then, they have been
continuously pressurizing me to withdraw the case and have been
regularly threatening and harassing me since long on regular basis.

Sir, on 11/04/2026 at around 1:30 PM, when I removed an
illegal barricading put up by them on the boundary wall of my house,
Alok Mandal forcefully entered my house without permission while his
wife Mita Mandal stood outside and supported him and thereafter
suddenly, he pushed me forcefully and as a result, I fallen down on the
floor and he along with his wife assaulted me with punch and kicks
and blows and tried to strangulate me by pressing my throat with an
intention to kill me, while his wife has caught the hold of my hands and
both of them were shouting that they will kill me and during such

assault the above Alok Mandal touched my bodily part and outraged my modesty. I somehow resisted and managed to save myself.

Sir, it is to be mentioned here that hearing the hue and cry the locals came and rescued me from the clutches of the above mentioned persons but the wrongdoers still abusing me with filthy languages and also cursed my innocent son without any reason and cause.

Sir, I am a helpless lady residing at my parents house and as I was so much traumatized with such frequent incident of the above mentioned person, I am feeling myself unsafe in the locality I am now living in fear for my safety and dignity inside my own home and due to such trauma late has been caused in lodging the F.I.R. but the above mentioned persons are still threatening me to kill me and my entire family openly as they have very good relations with anti-socials.

Therefore, I strongly request you to take immediate and strict action against both of them. If prompt action is not taken, there is a serious risk of further harm to me. I also request police protection as I feel unsafe and I request you to kindly investigate the matter properly and treat this complaint as FIR and please take necessary legal action against the aforesaid culprit as per the provision of law and oblige thereby.
