I, SMT. SOMA SEN @ SIMA SEN, Wife of Sri Biplab Sen, resident of Laketown, near Sunrise Club Shibani Apartment, Lake View Road P.S. New Jalpaiguri, District- Jalpaiguri beg to inform you that I resided along with my family at the ground floor of 4 storied apartment building in above mentioned address and in another flat situated at 3<sup>rd</sup> Floor of the same apartment one Srikanta Jena, son of unknown come to reside along with his family. On subsequent occasion a good and cordial relation was established between my family and his family as neighbour and also contact numbers were exchanged between my family and his family. But from the month of February, 2026 this Srikanta Jena started to call me frequently without any reasons and wants to talk with me and told me that he wants to become my friend. Firstly, he called me for lame reasons but these phone calls and messages through social media were increased day by day and one day he told me that he likes me but I told him that I saw him as my brother. He has continuously called me and messaged me in every social media platform.

On 03.02.2026 at 04:00 P.M. Srikanta Jena came at my flat entrance asked me to give some food as he told me that his wife has been gone somewhere and when he came to take food from my flat, he suddenly grabbed my hand forcibly with malicious intent and told me to come at his flat as he wants to spend time with me. somehow managed to escape from his hand and locked my door entrance.

It is pertinent to mention here that because of this Srikanta Jena's activity and behavior on 10<sup>th</sup> day of February, 2026 his wife namely, Mamina Bahadur Thapa, wife of Srikant Jena, came to my flat ferociously and asked me that did I have any illicit relation with his husband? I totally denied all such allegations but suddenly she charged on me and thrash me on ground and started to bit me with fist and blow. For this sudden charge I sustained injuries but somehow the other neighbours manage to rescue me from that attack. I went to lodge a police Complaint against these persons after but the total matter was settled and mediated by other neighbours.

From the month of April,2026 he has continuously messaged me and wants to talk with me but I blocked his number. But this person called me from many unknown numbers.

Now it is unbearable for me to live in this situation where I survive with constant fear of this person.

Kindly investigate the matter and take proper action against these person as per rule of law.
