I, PunamGanguly @ Punam Pradhan, daughter of Late Mani Kumar Pradhan, presently residing at Bartala Auto Stand, Kalkut, P.O. – Champasari, P.S. – Pradhan Nagar, District – Darjeeling – 734003, respectfully submit the following for your kind consideration.

That in the year 2008 I got married to Sri PintuGanguly, resident of Medical area under Matigara Police Station. Out of the said marriage we have two childrens.

That my husband PintuGanguly was a habitual drinker and used to physically torture me. With the support of my mother-in-law, we got separated in the year 2015 and since then I have been living separately at the above mentioned address and working to maintain my livelihood.

During this period I came into contact with one **Kunjan Prasad, son of Late Surendra Prasad, resident (as per Aadhaar Card) of Ward No. 4, GaurakshaniGajradh, Sasaram, District – Rohtas, State – Bihar – 821115, having mobile numbers 9993718716 and 9382666023. At present he is residing at Chandmoni, near Chandmuni Ground, P.O. & P.S. – Matigara, District – Darjeeling.**

Initially our relationship was normal. In the year 2022 he proposed marriage to me, it is pertinent to mention here Kunjan Know everything about me and my past life. Thereafter he started

living with me at my above-mentioned residence as my husband and I also lived with him as his wife.

In the middle of the year 2025 I became pregnant and presently I am about six months pregnant. During the initial stage of my pregnancy Kunjan Prasad used to provide me with necessary medical assistance. It is pertinent to mention that in the **“Mother and Child Protection Card (MCP Card)” issued by the Primary Health Centre, Upaswasthya Kendra, Saman Nagar, Matigara, the name of Kunjan Prasad has been recorded as the father of the upcoming child and my name has been recorded as Punam Prasad as the mother.**

However, after about five months of my pregnancy his behavior suddenly changed. He started living in a separate rented accommodation in Matigara and for the last one month he has completely abandoned me. That it is Kunjan Prasad who induce me to start a relation with him to gain a peaceful and secure life in future and upon believing over his assurance I entered into this relation.

Today morning, despite my pregnancy, I visited his rented house and requested him to take responsibility for me and our unborn child. However, Kunjan Prasad clearly refused and stated that he would not take any responsibility for me or the child.

Sir/Madam, I believe that Kunjan Prasad has exploited me for his sexual desires and now wants to abandon me without any reason. I am six months pregnant and he is responsible for the same. I am ready to undergo any medical test or examination to prove the truth.

After separating from my first husband, I tried to build an independent life. However, relying on the assurance given by

Kunjan Prasad, I entered into this relationship with the hope of a secure and peaceful future. Now I realize that he had dishonest intentions and has cheated and exploited me.

Therefore, I humbly request you to kindly register my complaint, take appropriate legal action against Kunjan Prasad, and conduct a proper investigation so that justice may be done.
