**SUBJECT: FORMAL COMPLAINT REGARDING FORCIBLE
ILLEGAL ENCROACHMENT, VIOLATION OF THE HON'BLE
CALCUTTA HIGH COURT ORDER, AND CRIMINAL TRESPASS
UNDER THE GUISE OF RELIGIOUS FESTIVITIES.**

Respected Sir,

I, Tultuli Oraon, W/o Diuse Kujur, D/o Late Ratia Oraon, resident of Ledey Busty, Kalkut, Champasari, P.S. Pradhan Nagar, Siliguri, do hereby lodge this formal complaint against the following individuals: Jagadish Roy, Kalicharan Das, Dr. Khagendra Nath Roy, Gopal Das, Md. Shabbir, Md. Sajjid, and other associated local Panchayat members of the ruling dispensation Trinamool Congress.

The grounds for this complaint are as follows:

1. Contempt of Judicial Order

The aforementioned individuals have willfully and maliciously initiated a forceful illegal encroachment upon my ancestral tribal land. This action is a flagrant violation of the standing order passed by the Hon'ble High Court at Calcutta. Despite being fully aware of the judicial restrictions governing this property, the accused are acting in total defiance of the rule of law.

2. Criminal Trespass & Land Grabbing

Under the pretext of organizing "Charak Puja," the named individuals have engaged in criminal trespass and illegal assembly. This is a calculated attempt to use religious sentiments as a shield for land grabbing and to alter the nature of my private property. I have a strict and absolute objection to any such activities or encroachments on my land.

3. Failure of Law Enforcement

It is deeply concerning that despite my repeated prior complaints regarding the activities of these habitual offenders, no deterrent action has been taken. The continued encroachment suggests a grave dereliction of duty and a failure on the part of the police administration to comply with and enforce the Hon'ble High Court's directives. The lack of police intervention is emboldening these offenders to bypass the constitutional rights of a tribal citizen.

4. Demand for Immediate Intervention

In light of the above, I urgently request your office to:

- Immediately halt all illegal activities and "Charak Puja" preparations on my ancestral land.
- Execute the order of the Hon'ble High Court in letter and spirit.
- Register an FIR against the named habitual offenders under relevant sections of the BNS (Bharatiya Nyaya Sanhita) for criminal trespass, intimidation, and contempt of court.
- Provide protection to ensure that my property rights are not further violated by these politically influential individuals.

Please treat this as an urgent matter. Should the police fail to act, I shall be compelled to move the Hon'ble High Court for contempt proceedings against the concerned authorities for their failure to uphold the law.
