Respected Sir,

I, **Amlan Gupta**, Son of Asit Kumar Gupta, resident of Pritilata Waddader Sarani, C/O- Mayer Ashirvad, South Deshbandhu Para, P.O.-Siliguri Town, P.S.- Siliguri, District-Darjeeling, Pin-734004, State-West Bengal, most respectfully submit this complaint for your kind consideration.

That on **29/03/2026 (Sunday)** at around **10:30 PM**, I went to purchase some items from a grocery store situated at "**Anurupa Store**", Sukanta Pally, near Balaka More, Siliguri, Pin-734005, While I was at the said place, **Mr. Pradip Bhattacharya (Sukul)**, owner of a adjacent shop (lottery) to the said grocery shop at **Sukanta Pally, near Balaka More, Ward No. 32 of Siliguri Municipal Corporation, PIN - 734005**, came there in an intoxicated condition and started using abusive and filthy language towards me without any provocation.

When I calmly objected to such behaviour, he suddenly became aggressive, pushed me, and thereafter attacked me with a stick, causing physical assault and injuries. The entire incident was captured in the CCTV camera installed at a house named "**Sarodalaya**", situated opposite to the place of occurrence.

Due to the said assault, I sustained injuries and had to undergo medical treatment, for which I possess valid medical documents and proof.

That the accused person has not only physically assaulted me but also caused severe mental agony, humiliation, and fear. He further intimidated me by threatening that if I take any legal action against him, he would assault me again in such a manner that I would not be able to stand on my feet. Due to such threats, I was initially afraid to take action but now I am ready to take legal steps against him.

Therefore, under the above circumstances, I most humbly request you to kindly register an F.I.R. against the said **Pradip Bhattacharya** and take immediate legal action in accordance with law. I also request you to provide necessary protection to ensure my safety.

I shall be ever grateful for your kind intervention.
