Sir,

I, **Smt. PRAMILA SARKAR**, Wife of Jaganath Sarkar, resident of Ghoghomali, Netaji Road, Netaji Para, Dist- Jalpaiguri, Pin-734006, State of West Bengal, would like to lodge a written complaint to the effect as narrated below:

1. That in the year 2001 my marriage was solemnized with one Sri Jaganath Sarkar and thereafter I reside in my matrimonial house along with husband. That subsequently from the said wedlock there is two issue/child namely Debraj Sarkar (Son) and Diya Sarkar (Daughter) and out of which the said Debraj Saerkar died in the year 2021 by accidental death.
2. That since our marriage, my husband has shown bad character and has been engaged in bigamous relationships with various women.
3. That from the very initial day of my marriage, my husband treated me as lower to earth, showing disrespect and cruelty in his behaviour. Despite this, as I am intimate to such relation, i thought that with time everything would get normalised and i tolerated his conduct in the hope of preserving peace in the family. However, instead of improving his behaviour it was been worsened.
4. That on 15.04.2026 my husband brought one such lady namely Beauty Mallick @ Rekha Mallick into our matrimonial home and started living together with her. When i protested to such unlawful and immoral act, the said lady


