I have business of Automobile Repair centre since 2015 in Kolkata. I have come to Siliguri for business opportunity and found a Place on Rent at Holding No 90(N/119/2550), Upper Bhanu Nagar, 2nd Mile, Sevoke Road, Beside Alishan Hotel, Siliguri-734001 in the month of December 2025. **Bikram Tewari, S/o- Meghnath Tewari, Upper Bhanu Nagar, 2nd Mile, Sevoke Road, Beside Alishan Hotel, Siliguri -734001**, the Landlord of the place agreed to give the place on Rent. I started the construction work from 1st November 2025 and stayed at the property since then. I have requested the Landlord several times for the rent agreement but he delayed the agreement process and not done yet.

I have invested more than 10 Lacs on the construction work (Annexure-1) and I have Machineries and equipment and my car, customers car worth more than 60 lacs (Annexure-2) at the place.

On completion of my Workshop Bikram Tewari creating problem and threatening me to leave the place and he will take over my business. He had thrown me and my wife out of our residence and locked the room.

Today, 5th April, 2026, Bikram Tewari had called us for discussion. Me and my wife went for the discussion but there were four other men and his wife ~~(Name)~~ at his office. All of them harassed us in filthy language and threatened us for bad consequences. Bikram Tewari warns me not go to any police station as he is very powerful and politically connected person.

Request your help me to recover my hard earned equipment and money.
