Dear Sir,

I the undersigned would like to inform you that I am the registered owner of a piece of land measuring about 33 decimal, recorded in L.R Khatian no. 1601, L.R Plot no. 82, Mouza Palash, P.O Champasari, P.S Pradhan nagar, Dist. Darjeeling, by virtue of a registered sale deed no. 4369 for the year of 2010. (Photo copy of sale deed and Khatian is annexed herewith as annexure 'A' & 'B')

I would like to further inform you that, my brother Sri Baichung Bhutia and my sister Smt. Diki Doma Bhutia are also the registered owner of a piece of land measuring about 20 Decimal and 18 Decimal by virtue of two separate sale deeds being no. 6667 for the year of 2010 and 6666 for the year of 2010 and said total 38 decimal land is situated just my adjacent land.

I would like to further inform you that, One Smt. Sarita Minj, Wife of Abhijit Kanjilal of Raviata, P.O Leusipakuri, P.S Phansidewa, Dist. Darjeeling, had started to disturb our peaceful possession of the said landed property and they also demanded the money most illegally and ultimately for protecting the possession of the said landed property I have filed a civil suit being T.S No. 211 / 2017 and my brother and sister have also jointly filed another suit being T.S no. 210 / 2017 before the Learned Civil Judge Junior Division Siliguri and in both the said suits Learned Court was pleased to grant temporary injunction in the way of status-quo in respect of the nature and character of the suit property till disposal of the suit vide its order dated 30/05/2018. (Photo copy of order dated 30/05/2018 is annexed herewith as annexure 'C')

I would like to further inform you that, inspite of the said injunction order dated 30/05/2018, said Sarita Minj and her men and persons had entered into the said landed property and engaged her persons for making temporary structure on 15/07/2019 in violation of the said injunction order and for that I have lodged a written complaint to your good office on 16/07/2019. (Photo copy of complaint dated 16/07/2019 is annexed herewith as annexure 'D')

I would like to further inform you that, thereafter I have informed the matter regarding the said violation to the Learned Court and after hearing, the

Learned Court was pleased to direct you to implement the order of injunction dated 30/05/2018 vide its order dated 16/11/2019 and said order was duly communicated to you from the Learned Court. (Photo copy of order sheet dated 16/11/2019 is annexed herewith as annexure 'E')

I would like to further inform you that, during pendency of the said suit, said Sarita Minj had executed a sale deed infavour of one Sri Binod Lepcha, Son of Sri Lakpa Tshring Lepcha, Resident of Gangtok, Sikkim, vide sale deed no. 07279 for the year of 2023 and she also executed another sale deed through constituted attorney namely Kalin Barman, Son of Suren Barman of Pradhan Nagar, to and infavour of one Smt. Tashi Ongmu Bhutia, Wife of Partiman Rai of Gangtok Sikkim, vide sale deed no. 02518 for the year of 2025 keeping in dark and she also did not disclose the matter to court also.

I would like to further inform you that, after getting the above mentioned illegal act of said Sarita Minj, I rushed to the said landed property and found that the above noted persons have entered into the said landed property and made a temporary structure by bamboos and CI sheet roofing and dig the earth for the purpose of one well and they have demolished a considerable portion of boundary wall and they also dumped the building materials like sand, stone chips, cement, bricks, iron rod etc., inside of the said landed property. After reaching there I protested the said illegal act but Kalin Barman alongwith One Subal Barman, Son of Late Niren Barman of Methibari, (mobile : 9832453120), they became very violent and abused filthy languages by saying that if I will again enter into the said land they will not hesitate to kill me.

Under the above circumstances I would like to request you to investigate the matter and implement the order dated 16/11/2019 as passed by the Learned Court and do needful for the ends of justice.
