Sub: Complaint

Sir,

With due respect, I SI Pratap Basak of Bagdogra PS, SPC do hereby lodged a written complaint against the unknown driver and owner of a vehicle (Truck) bearing Reg No-WB 59 D 1986 to the effect that on 07.04.2026 while performing K-35 van duty at about 06.20 hrs received an information that one vehicle bearing Reg No-WB 59 D 1986 was parked in front of Gurudwara near Bihar more in abandon condition. Accordingly, I informed the matter to the O/C Bagdogra PS and as per his kind direction I along with force had been to Gurudwara near Bihar More. After arrived at the spot found one vehicle (Truck) bearing Reg. No- WB 59 D 1986 was parked in front of Gurudwara. Then I conducting searched around the vehicle and found no one there. After through searching found 20 nos of Buffaloes was loaded inside the said vehicle and no one came with proper documents/license in respect of this vehicle and buffaloes. It is clearly indicated that this 20 nos of Buffaloes were loaded in purpose of smuggling and illegally transport for wrongful gain and the driver and others associates fled away from the spot keeping the vehicle in abandon condition as the vehicle was breakdown. Then I recovered the 20 nos of Buffaloes and seized the vehicle bearing Reg No WB 59 D 1986 along with the Buffaloes under proper seizure list. The search and seizure was made in between 07.30 hrs and 07.35 hrs on 07.04.2026. The seized 20 nos of buffaloes was handed over to the Naxalbari pond vide receipt no- 625, Dated-07.04.2026.

I, therefore requested to you kindly registered a specific case under proper section of law against the driver and owner of the vehicle bearing Reg No- WB 59 D 1986 and cause its investigation.
