Subject: **Request for registration of a case against cattle smugglers.**

Siliguri Police Commissioner

Respected Sir

1. On the basis of information received regarding possible cattle smuggling via AH-02 a QRT Party of coy hqr Madanjote under the command of UIN-14080192 ASI(GD) Arjun Rai, along with 07 other personnel on early morning of 08/04/2026 moved towards Kristopur village AH-02 from govt veh no WB 74 BP 9563&BR-01 GQ 3562. while approaching towards Kristopur a Eicher Pro 3019 NO. WB 73 G 5977 (Red color) coming from AH02 was seen after seeing our govt vehicle they speedup the truck we chase and caught a truck loaded with cattle inside along with 4 person who are driver and Laboure of this truck. a thorough search was conducted after that 27 NOS OF Cattle (cow & calf) with a Eicher pro 3019 (heavy truck) with key and 03 mobile phone of apprehended person were seized. Along with four apprehensions namely-

Apprehended person reveled that Md. Samim of Aaluabari Islampur (A Notorious Cattle Smuggler) purchase these cattle from Bihar & intended to transport them to Shreerampur border Assam for further illegally transport these cattle to Bangladesh with the help of a person namely Raj Gupta of Matigara Siliguri.

The manner in which the cattle were loaded and also not showing any document related to these cattle transportation clearly indicated intention to illegally transport and cruelty towards those cattle. A seizure memo was duly prepared in the presence of force witnesses as per prescribed procedure.

In view of the above these Seized cattle 27 Nos. & Eicher Pro 3019 truck NO. WB 73 G 5977 (Red color) along with all four apprehended persons are being handed over to Bagdogra Police Station on 08/04/2026 at hrs. for further lodging a Fir against these cattle smuggling syndicate and legal action.
