Sir

As per Complaint received from our consumer vide Consumer ID 403350054, named JPR Bhumi Developers, C/o Jitendra Kumar Mahato regarding no power, vide docket no 93382361 dated April 8th 2026 at 10:50:09. While attending the complaint it was observed that some parts of the Transformer located at Hansqua Muni More Diamond Crown was missing. Nearby another transformer for powering PHE(water) consumer at Hansqua Muni More was found missing. For both the Transformers the estimated cost of missing items are as follows:

The power was restored at approximately 16:45HRS thereby maintaining stable power to the complainant.

For Stable Power Operation of Transformers these parts are essential. Therefore I would like to request you to kindly investigate the matter as some unknown miscreants might have stolen these parts from existing structure and treat this as F.I.R. under Section 136 1(a) of The Indian Electricity Act.
