while approaching towards Kestopur a Mahindra Bolero Maxx (pik-up) VEH.NO.WB 73 R 6260 (White color) coming from Kestopur was seen after seeing our vehicle, they speedup the pickup we started chasing they stop the pickup far away from us and taking advantage of dark they flee away, a thorough search was conducted after that 06 NOS OF Buffalos with a Mahindra Bolero Maxx (pik-up) VEH.NO.WB 73 R 6260 (White color) were seized.

The manner in which the cattle were loaded clearly indicated intention to illegally transport and cruelty towards those cattle. A seizure memo was duly prepared in the presence of force witnesses as per prescribed procedure.

In view of the above these Seized cattle 06 Nos. & Mahindra Bolero Maxx (pik-up) VEH.NO.WB 73 R 6260 (White color) are being handed over to Bagdogra Police Station on 15/04/2026 at hrs. for further lodging a Fir against vehicle owner and person involved in this
