Respected Sir,

I, **SMT. ANIMA ROY**, W/o. Akash Ghosh & D/o. Late Bijay Roy, resident of New Paul Para, SMC Ward No. 38, P.S. Bhaktinagar, Dist. Jalpaiguri, would like to draw your kind attention to the following effect as follows as under:-

1. That on 11th day of February, 2025 one agreement has been executed between me and **RABINDRA NATH BASAK** at my house in connection with lease of my vehicle, vide, Reg. No. WB73 E 8668, Model - Innova Crysta i.e. the period for one year and the rent of the said vehicle has been decided to a sum of Rs. 30,000/- (Rupees Thirty Thousands) only per month and I am the actual owner of the said vehicle.
2. That the rent of the said vehicle has been paid up to December, 2025 and the rest amount of Rs. 30,000/- has not been paid by the said person till the date of 14.04.2026 and the said vehicle has been delivered to me on the said date i.e. on 14.04.2026 on the basis of few more request to said **RABINDRA NATH BASAK** and when I have seen my vehicle then the battery of the said vehicle has been destroyed and the tyre and the body of the said vehicle was in danger position and also the luggage carrier of the said vehicle has been stolen from the roof of my vehicle and the said vehicle has been brought by another person namely **BAPI SARKAR @ SANDIP SARKAR** and when I have asked him about the condition of my said vehicle then he has told me that said Rabindra and bapi both together damaged my car and he can do what he wants and I have told him to pay the total amount of Rs. 1,20,000/- which became due from the month of January, 2026 to April, 2026 then he started abuse me by using slangs and also threaten me that they will not paid demurrage and the rents.

So, I, fervently request you would kindly take a legal step against **RABINDRA NATH BASAK & BAPI SARKAR @ SANDIP SARKAR** then I shall remain ever grateful to you and oblige thereby.
