### Subject: Complaint regarding theft of donation box from temple premises

Respected Sir,

I, Jayanta Saha, Joint Convener of Sri Sri Siddheshwari Kali Bari Management Committee, beg to state that Sri Sri Siddheshwari Kali Bari is situated at Station Feeder Road, Ward No. 9, under Siliguri Municipal Corporation, P.O. Siliguri Bazaar, P.S. Siliguri, District Darjeeling, PIN – 734005. The temple premises houses permanent temples of Maa Kali, Lord Shiva, and Goddess Durga.

It is to inform you that on 16th April 2026 (Thursday), at approximately 16:35 PM, an incident of theft took place within the temple premises. As per the CCTV footage installed inside the compound, an unidentified man was seen taking away the donation box (Pranami Box) from the Shiva temple. The matter came to our notice today morning (17th April 2026) when the temple was opened for daily routine. The relevant CCTV footage has been preserved and is being submitted along with this complaint for your kind perusal.

In view of the above, I humbly request you to kindly treat this matter as an FIR, conduct a thorough investigation, identify the accused person, and take necessary legal action. I also request you to take steps for the recovery of the stolen donation box at the earliest.

I shall remain grateful for your prompt action in this regard.
