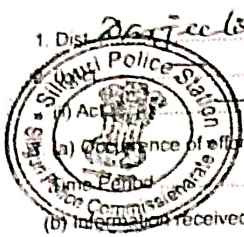

Sir,  
In producing here with the one arrested accused person namely MD Jakir 24 yrs S/O Late Md Javed Ali Of Bash Bari, Madani Bazar, Near Musjid, PO- Sahudangi Hat, PS- NJP Dist- Jalpaiguri along with the seized articles, with all connecting papers.

I ASI Subir Sen S/O late- Sachindra Nath Sen of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely MD Jakir 24 yrs S/O Late Md Javed Ali Of Bash Bari, Madani Bazar, Near Musjid, PO- Sahudangi Hat, PS- NJP Dist- Jalpaiguri to the effect that on 18.04.2026 at about 20.55 hrs while performing PC mobile van duty (vide GDE no 1094 dated- 18.04.2026) source informed me that one person namely MD Jakir is storing and selling huge quantity of liquor illegally, at Jalpaimore, near Traffic Office, under Siliguri PS. Accordingly I informed to IC Siliguri PS and as per his direction, myself along with ASI Debasish Das, ASI Minhaj Al Kader, Const- 160 Soumen Sarkar of Siliguri PS left for Jalpai More, to verify the veracity of the information. At about 21.05 hrs I along with my accompanied police team reached at Jalpaimore. and kept our vehicle at considerable distance from the spot and on being shown and identify by the source, I along with my accompanied team held raid against the Md Jakir and managed to apprehended the said persons. On searched I recovered Ten (10) bottles of Himalayan gold 60 up Country spirit each bottle containing 600 ml, On interrogation he disclosed his identity as MD Jakir 24 yrs S/O Late Md Javed Ali Of Bash Bari, Madani Bazar, Near Musjid, PO- Sahudangi Hat, PS- NJP Dist- Jalpaiguri. On demand he failed to produce valid license or documents in r/o said liquors. On further interrogation he admit his guilt and stated that he sells the liquor to his design customers without valid licence or documents for his wrongful gain. Accordingly as he violated the rules and norms of Bengal excise act, as such I seized the same viz Ten (10) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml (total 06 liters) and each bottle M.R.P Rs- 170/- (Total value of seized articles 12X170= Rs-2040/-) from the exclusive and conscious possession of MD Jakir 24 yrs S/O Late Md Javed Ali Of Bash Bari, Madani Bazar, Near Musjid, PO- Sahudangi Hat, PS- NJP Dist- Jalpaiguri ( the searched, seizure and labelled was made in between 21.15 hrs to 21.35 hrs) the whole processes of search and seizure was made under video graphed in presence of available witnesses, duly sign by the accused as well as witnesses. Then I arrested him u/s 35(1) of BNSS after appraise the ground of arrest and issued arrest memo in presence of witnesses.




