In producing herewith 04 (four) arrested accused persons namely (i) Rakesh Das (M/22 Yrs.) S/O Bhavani Das of Satrampur, , Gurirpur, P.S- Tufanganj, Dist.- Cooch Behar A/P Jhankar More, Ward No. 07 of SMC, P.S- Siliguri, Dist.- Darjeeling (ii) Sanjoy Mandal (M/ 30 Yrs.) S/O Lt. Ram Chandra Mandal of Bagrakote , Sovan nagar, Ward No. 18 of SMC, P.S- Siliguri , Dist.- Darjeeling , (iii) Chengiz Khan (M/ 31 Yrs.) S/O Abdul Haziz of Dangipara, Railway Over Bridge, Ward No. 06 of SMC, P.S- Siliguri, Dist.- Darjeeling and (iv) Safik Islam (M/ 23 Yrs.) S/O Md. Sahidul Islam of Natun para, Ramghat, Ward No. 05 of SMC, P.S- Siliguri, Dist.- Darjeeling along with the following seized articles under seizure as per seizure list :-

- (iv) 01 (one) Iron made rod measuring approx 61 cm in length which is found on the right hand of the accused named Safik Islam (M/ 23 Yrs.) S/O Md. Sahidul Islam of Natun para, Ramghat, Ward No. 05 of SMC, P.S- Siliguri, Dist.- Darjeeling

I PSI Mrityunjoy Kundu of Khalpara TOP-II under Siliguri PS, SPC do here by lodged this written complaint against the above noted accused persons and 09/10 others to the effect that on 19.04.2026 at 00.05 hrs., received a source information that approx 13/14 youths were assembled at Jhankar More, near abandoned field of Power House, Ward No 07 of SMC under Siliguri PS with a view to commit Dacoity in a Night Super Bus passes through Jhankar More. The fact has diarized in Khalpara TOP GDE No- 584 dated-19.04.2026. Subsequently, after sharing the information with my superiors and as per their direction, at 00.15 hrs. myself along with officers & forces of Khalpara TOP left for Jhankar More, near Power House, Ward No 07 of SMC under Siliguri PS to work out the information along with investigation kit to verify the veracity of the information vide Khalpara TOP GDE No- 585 Dated- 19.04.2026.

On the way to Jhankar More, I contacted with two independent witness namely (i) Md. Muktar Alam (M/36 Yrs.) S/O Md. Maziruddin of Jyotinagar Colony, Ward No. 04 of SMC, P.S- Siliguri, Dist.- Darjeeling (ii) Md. Sarafat S/O Evis Mastar of Tikiya para, Mazdur Colony, Ward No. 28 of SMC, P.S- Siliguri, Dist.- Darjeeling and make them aware about the information and requested him to act as witness, if any search and seizure would be made necessary upon which they agreed.

Thereafter, we along with the independent witness noted above reached at Jhankar More, near Power House, Ward No 07 of SMC under Siliguri PS at 00.25 hrs. and being pointed by the source cordoned off the suspected persons with strong reason to believe that they were preparing to commit some cognizable offence in our locality. Seeing the police personnel they tried to flee away but on hot chase we managed to apprehend above noted 04 (four) accused persons along with seized articles as mentioned above. However the other 09/10 persons manage to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a Night Super Bus passes through Jhankar More area under Siliguri Police Station.

I therefore, seized the above noted weapons under proper seizer list duly signed by the witnesses and acknowledged by the accused persons. The whole search and seizure was made in between 00.40 hrs. to 00.58 hrs. under proper videography in presence of independent witnesses. Thereafter I arrested the above noted accused persons under proper memo of arrest duly signed by the accused persons.

On further interrogation the arrested accused persons stated that they were gathered there to commit dacoity in a Night Super Bus passes through Jhankar More area under Siliguri Police Station. It is also revealed from them that 09/10 other associates were managing to flee away from the spot taking the advantage of darkness.

Under the above noted facts and circumstances, I pray to you that a specific case under proper sections of law may kindly be started against the accused persons namely (i) Rakesh Das (M/22 Yrs.) S/O Bhavani Das of Satrampur, Gurir pur, P.S- Tufanganj, Dist.- Coach Behar A/P Jhankar More, P.S- Siliguri, Dist.- Darjeeling (ii) Sanjoy Mandal (M/ 30 Yrs.) S/O Lt. Ram Chandra Mandal of Bagrakote, Sovan nagar, Ward No. 18 of SMC, P.S- Siliguri, Dist.- Darjeeling, (iii) Chengiz Khan (M/ 31 Yrs.) S/O Abdul Haziz of Dangipara, Railway Over Bridge, Ward No. 06 of SMC, P.S- Siliguri, Dist.- Darjeeling and (iv) Safik Islam (M/ 23 Yrs.) S/O Md. Sahidul Islam of Natun para, Ramghat, Ward No. 05 of SMC, P.S- Siliguri, Dist.- Darjeeling and others and arrange for its investigation.
