Sir,

In producing herewith one arrested accused person namely Riki Puri (M/39 yrs), S/O - Lt. Nirmal Puri of Iskon Mandir road, P.S- Bhaktinagar, Dist- Jalpaiguri along with seized articles (1) 10 (Ten) sealed Bottles of 80 UP PET Himalayan Tuk Tuk each bottle containing 600 ml. each of Rs. 70 Total (10 x 70)= 700 /- (2) 01 (One) Nylon Bag which was used for carrying the seized articles SL. N- 1.

I, ASI. Biswajit Saha of Panitanki TOP under Siliguri PS hereby lodge this written complaint against the above noted accused person to the effect that on 19.04.2026 at 21.15 hrs received secret source information that one person is carrying huge quantity of country spirit bottle through Sevoke Road and approaching towards Iskon Mandir. Accordingly informed the same to O.C Panitanki TOP and diarized the matter at Panitanki TOP vide Panitanki TOP GDE No. 493, dated 19.04.2026 and thereafter as per his direction I along with, ASI Ratan Kr. Ghosh, C/1036 Gopal Srivastav and C/114 Naresh Hasda left from Panitanki TOP to work out the veracity of information. On arrival near Panitanki More, Siliguri at 21.25 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit carrying in a Nylon bag. Accordingly I have intercepted & apprehended him. Then I searched him in presence of two independent witnesses named (i) Rakesh Kurmi S/O- Lt. Ramesh Kurmi of Bidhan Road, Ps-Siliguri, Dist.-Darjeeling & (ii) Jayanta Roy S/O Biky Roy of Bidhan Road, Ps-Siliguri, Dist.-Darjeeling and recovered 10 (Ten) sealed Bottles of Himalayan Gold Country Spirit each bottle containing 600 ml. each. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sell the same illegally to the local public of Mahakalpally and adjacent areas for his wrongful gain and livelihood. Accordingly I seized the (i) 10 (Ten) sealed Bottles of 80 UP PET Himalayan Tuk Tuk each bottle containing 600 ml. each of Rs. 70 Total (10 x 70)= 700 /- (ii) 01 (One) Nylon Bag which used for carrying the seized articles SL. N- 1 under proper seizure list and labeled the same in presence of witnesses and duly sign by them and also by the accused person. The seizure was made in between 21.33 hrs and 21.45 hrs. Then I arrested the accused person u/s 35 BNSS after explaining charges against him.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person Riki Puri (M/39 yrs), S/O - Lt. Nirmal Puri of Iskon Mandir Road, P.S- Bhaktinagar, Dist- Jalpaiguri for starting a specific case under proper section of Law and to arrange for its investigation.
