With due respect, I, Sweta Ahmed @ Sweta Saha, Wife of Saiyed Saleem Ahmed and Daughter of Late Sambhu Saha, residing at Purna Kutir, J.C. Bose Road by Lane, Hakimpara, Near Swapnaneel Bhawan, Khelaghar More, P.O. & P.S. Siliguri, Dist. Darjeeling-734001 (W.B.), beg to state as follows:-

- 1) That I was born in a Hindu family and I was/am residing at Purna Kutir, J.C. Bose Road by Lane, Hakimpara, Near Swapnaneel Bhawan, Khelaghar More, P.O. & P.S. Siliguri, Dist. Darjeeling with my widow mother and other family members.
- 2) That in the year of 2009-2010, I was studying at Kendriya Vidyalaya, Bengdubi, Bagdogra, Dist. Darjeeling and Mr. Saiyed Saleem Ahmed was also a student of same school and he was my one year junior and since then, we were introduced each other and we became good friends. It may be mentioned here that at the relevant time, he along with his family members were residing at Siliguri.
- 3) That thereafter, we both grown up and our friendship gradually developed into love affair and ultimately we had decided to marry each other.
- 4) That said Saiyed Saleem Ahmed told me before entering into marriage, I must be converted from Hindu to Muslim and thereafter to enter into marriage with him as per Muslim Rites & Customs.
- 5) That ultimately I was converted from Hindu to Muslim as per Muslim Customs and thereafter, I entered into marriage with said Saiyed Saleem Ahmed on 08.06.2019 as per Muslim Rites & Customs and our marriage was solemnized at New Town, Kolkata and after marriage, I along with said Saiyed Saleem Ahmed started to live together as wife and husband at House No. 52, 1st Floor, APJ Abdul Kalam Road by Lane, 11, F. Ali Road, 6 Mile, Bormotoriya, Guwahati, Assam.
- 6) That at the time of marriage, I was working at TCS. After marriage, I was forced to leave my job and I was never allowed to work again and became completely financially dependent on my husband and his family.

7) That thereafter, out of our wedlock, a male child was born on 11.09.2021 namely Saiyed Izhaan Ahmed at Pratiksha Hospital, Guwahati, Assam who is now under my custody.

8) That at the time of marriage, my parents have given valuable golden ornaments to me and also given golden chain and finger ring to my husband and my father also given valuable furniture as per demand of my husband and his family members and all the articles and furniture were brought to my matrimonial house and entrusted the said Stridhan Properties along with my husband and in-laws.

9) That from the beginning of marriage, my mother-in-law namely Mina Sultana Ahmed and my two sister-in-law namely Mehzabin Ahmed and Jabina Ahmed tortured me in various way and they also insisted my husband to create torture upon me.

10) That the torture upon me was increased day by day and my husband did not hesitate to assault me physically in presence of his other family members.

11) That in the month of May 2024, when my grand-mother passed away, I wanted to come to Siliguri to attend her last rites. My husband and my mother-in-law and sisters-in-law threatened me and even contacted the police to stop me on the road and the said incident deeply traumatized me and made me fear for my safety.

12) That I underwent a C-section delivery, but even after such a major surgery, I was not given proper food, nutrition, or medical care and for which, my health deteriorated badly and I lost a lot of weight and became underweight and frequently fainted.

13) That my husband and his family repeatedly tried to portray me as mentally unstable so that they could take my minor child away from me.

14) That thereafter, my father passed away, the abuse increased significantly. My mother was forced to sleep on the floor and her bed was taken away, only because she supported me.

15) That in the month of May 2024, my husband and his mother and other family members misbehaved with me and my minor son and me and my minor son were driven out from their house by keeping all the belongings

and jewelleryes at their house and since then, I along with my minor son have been residing at my parental house.

- 16) That after few days, when I requested my husband to take me at my matrimonial home, he misbehaved with me and he threatened that he will never allow me in his house.
- 17) That thereafter on 24.01.2026, my husband came to my parental house and physically assaulted me and when my mother tried to save me from his hands, he also assaulted my mother and for which, my mother sustained injury on her eyes but I did not lodge any written complaint to the Police Station against my husband with a hope that he will rectify himself.
- 18) That again on 01.04.2026, my husband came to my parental house and physically assaulted me and also tried to take away my minor son from my custody and when I tried to resist him, he became furious and assaulted me.

So, I therefore, request you to investigate the matter and to take necessary legal action against my husband Saiyed Saleem Ahmed, my mother-in-law Mina Sultana Ahmed, sister-in-law namely Mehrazbin Ahmed and Jabina Ahmed, all are residing at House No. 52, 1st Floor, AFJ Abdul Kalam Road by Lane, 11, F. Ali Road, 6 Mile, Bormotoriya, Guwahati-781022, Assam according to law. And for this kindness, I shall much oblige to you.
