I the undersigned would like to state you the following:-

1. That I married with one Soujannya Chakraborty, Son of Sri Nishit Chakraborty being permanent resident of B.Ed. College Road, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling.
2. That the marriage was first registered under The Special Marriage Act 1954 on 14.05.2013 before the Additional District Sub-Registrar cum Ex-Officio Marriage Officer, Siliguri, Dist. Darjeeling (Page No.59, Case No.93/2013 dated 02.04.2013, Regn. Sl. No.118/13).
3. That the social marriage took place according to Hindu rites and customs on 07.12.2013 at Soubhagya Palace, Ward No.13 of Siliguri Municipal Corporation, P.S. Siliguri, Dist. Darjeeling.
4. That after marriage my husband took me to his parental house at B.Ed. College Road, P.O. Kadamtala, P.S. Matigara, Dist. Darjeeling where we started to live as husband and wife and our marriage was consummated thereon.
5. Thereafter my husband took me to his work places firstly in Mumbai and thereafter in Kolkata where there was continuation of his physical and mental abuse and my mother in law namely Jharna Chakraborty who was also frequently present at those places use to always interfere in our matrimonial life and used to use expletives and innuendo in front of neighbors and in the house hold itself.
6. That my husband had a typical habit of pledging my gold ornaments for obtaining loan and currently he is enjoying such loan for his own personal gains.
7. That my husband is a habitual drunker and use to beat me up without any rhyme or reasons from the inception of our marriage.

8. After marriage at matrimonial home my mother in law Jharna Chakraborty and my brother in law Souhardhya Chakraborty use to instigate my husband to beat me up and they use to abuse me physically and mentally.
9. That to buy matrimonial peace and according to the demand and wishes of my husband, mother in law and brother in law, my father helped (made the down payment) my husband to purchase a flat measuring about 952 Sq.Ft. which was registered in my name and that of my husband. The flat is situated at Flat #7C, Classic 1, Block 2, Unimark Springfield, Rajarhat, Kolkata 700135.
10. That in the year of 2018 I came to know that my husband is in multiple relationship and is cheating on me which caused me great mental agony. That my husband is now in an extra martial relationship with a women namely Chandrima Chatterjee working at Globiva at 4th Floor, PS Srijan Tech Park, DN-52, Salt Lake City, Sector V, Kolkata - 700091.
11. That when I protested I was asked to confirm with his way ward habits or else leave his matrimonial home.
12. That during my stay at the before mentioned matrimonial home at Shivmandir I was barely allowed to stay in contact with my parental home and if I made any attempt to contact with my parents or other relatives my husband, my mother in law and brother in law, use to physically and mentally abuse me.
13. That I being a girl born and brought up with middle class values always use to hope a better future for ourselves.
14. That I always insisted my husband to start a family (to conceive a child) but he postponed the plans citing financial incapacity and also that my mother in law would not approve off the same.
15. That my husband is currently posted at a senior executive level in an IT company namely Teleperformance, having its registered address at 10, Plot No.20, Tower 21, Noida-Greater Noida Expy, Sector 135, Noida, Bajidpur, Uttar Pradesh.
16. That my husband from 2024 have permanently left me at his parental house (my matrimonial home) at Shivmandir, leaving me alone and in a state of abandonment.

17. That on 9th of April 2025 I was compelled to leave my matrimonial home in a single wearing, my in laws as instructed by my husband has kept all my wearing apparels, gold ornaments and on being asked to give the same have refuse to give me threatening me with dire consequences.

So, I request your good offices to kindly investigate the matter and take necessary action against my husband Soujannya Chakraborty, his mother Jharna Chakraborty, his brother Souhardhya Chakraborty
