Respected Sir,

With due respect I Smt. Subhashree Das, wife of Sajal Sarkar, Daughter of Sri Sushil Chandra Das, resident of Tumba Jote (near Tiranga More), Post and P.S. Matigara, District Darjeeling, PIN 734010. I am lodging this complaint to the effect that:

1. That On 20-07-2014, my marriage was solemnized according to Hindu social rites with Sajal Sarkar, son of Prantosh Sarkar, resident of Alipur, Ghoshpara, P.S. Chakdah, District Nadia. Subsequently, I began living with my husband at my in-laws' house. It is pertinent to mention here that at the time of my marriage as per demand of my husband and in-laws my father arranged dowry of Rs.2,00,000/- (Rupees Two Lakh) only in Cash along with other gold articles and furniture.
2. That after elapse of a good period of 6 months. I have started noticing some significant changes in the behavior of my husband as well as my father-in-law named Prantosh Sarkar & mother-in-law Jalpana Sarkar. It is not out of place to mention here that after some days of my marriage my husband asked me to give all my gold ornaments to my mother-in-law being a young newly wedded wife I agreed to deposit all my gold ornaments to be safe as my mother would take care of that. It is not improper to mention here that as soon as I deposit all my gold ornaments my husband and in-laws have changed their colour and started inflicting upon me and also placed more demand of dowry.
3. That Unable to bear my condition, my father, Sri.Sushil Chandra Das, arranged for Rupees 20,00,000/- (Rupees Twenty Lakh) only in cash and handed it to my husband, Sri.Sajal Sarkar, which reduced the

torture to some extent. In 2017, I gave birth to a son named Jimith Sarkar who is currently 9 years old.

4. That I hoped that after providing the dowry amount and the birth of my minor son the attitude of my in-laws and husband will soften towards me but even after the birth of my son, my husband's behavior changed abruptly again. He was constantly addicted to his phone and spent most of his time outside. When questioned, he would attack me, beat me, and use foul language. I later learned he was in an extramarital relationship with an unknown woman and he was also involved in gambling. When I told my father-in-law, he replied, "This is common nowadays". When I protested, he blamed and insulted me instead. My husband and in-laws resumed physical and mental torture against me and my son. When I protested against the atrocities committed by my husband and my in-laws and inquired for my gold and furniture, my husband beat me severely. And even after this thinking about the future of my son and my family I tried to live with my husband.
5. That again in the mid of 2016 when my husband started committing more torture upon me during my pregnancy and when I protested against these activity if his then he forcibly have been living separately for the last four years. During this time, my husband came to my father's house multiple times, pressured me to return, used abusive language, and gave death threats. Witnessing my condition and my husband's behaviour, my father named Sushil Das (now deceased) suffered a heart attack and passed away. It is pertinent to mention here that during my father's funeral rites, my husband was present and attacked me in front of relatives over a minor issue, damaging a portion of the house veranda.
6. That it is pertinent it to mention here that during my pregnancy in the year 2016 my husband told me to live at my paternal house and till the birth of my son I have stayed at my paternal house as per the wish of my husband. After the birth of my son in the year 2017 as per the wish of my husband I returned to my matrimonial house and intermittently I used to visit my paternal house. Then finally me and my husband came to Siliguri and resumed our nuptial life. Now I find it important to mention here that on 27-11-2023 my husband insisted

me to purchase a two wheeler vehicle and as per wish of my husband I purchased the two wheeler vehicle bearing registration number WB 74 BK 6569 on E.M.I basis from L & T Financial services. 19-02-2024 my son fell sick and he was admitted at Medica and during that time my husband did not take any responsibility of me and my minor son and also he did not pay any amount for maintaining us during this time. When I requested him to look after our son he denied to look after him packed his bags and left with my two wheeler vehicle and when I called him he told me not to call him and from then on me and my son started living on our own at TumbaJote (near Tiranga More), Post and P.S. Matigara, District Darjeeling, PIN 734010. Even after that he used to come intermittently and abuse and attack and me and my son and he also sent his goons to attack me.

7. That a two wheeler vehicle had been purchased in my name bearing registration number WB 74 BK 6569 on E.M.I basis from L & T Financial services and the loan has been cleared by me but unfortunately my husband has forcibly taken possession of the said two wheeler vehicle and when I requested him to return it to me he refused to return it and threatened me with dire consequences.
8. That in these four years, he has taken no responsibility for the maintenance of me or my child. Whenever I asked for maintenance for myself and our minor child, he abused me and threatened to kill us.
9. That on 31-12-2025 he threatened to kill me and my family and again on 02-01-2026 my husband pelted stones at my house endangering the my and my family's life and when I raised hue and cry people of locality came to my rescue and resultantly he had to flee from there but before leaving he threatened me with murder and dire consequences but being an Indian woman I did not lodge any complaint and on 01-04-2026 I admitted my son to Birla DivyaJyoti School in Class-IV and the school authorities told me to submit my son's original adhar card and when I requested my husband to give Birth certificate of our son so that I can apply for the adhar card of behalf of my son my husband told me that he has already destroyed our son's original birth certificate and also told me that I will not be

able to do anything to arrange the adhar card with out the original birth certificate of our son.

I, therefore pray before you to look into the matter as my child, my mother, and I are living in constant fear. I cannot live with my husband under these circumstances; otherwise, there is a risk to our lives and overall safety. Therefore, I request you to take appropriate legal action against my husband, Sri Sajal Sarkar, and his family.
