Sub: - Complaint

Sir,

In producing herewith two arrested accused persons namely (1) Md Rashid-24yrs s/o Lt Md Jainuddin of Kaluajote, PO+PS Naxalbari Dist Darjeeling and (2) Kishan Sarki-21yrs s/o Dipen Sarki of Bagrakote TG, Bank Line, PS Malbazar Dist Jalpaiguri along with the following seized articles as per proper seizure list viz:

- (1) 31 (Thirty one) pet bottles of SIKKIM KNIGHT special Whisky each bottle containing 750 ML (23.250 Ltrs, amounting Rs- 189 X31=5859/) Blended and bottled by MOUNT Distilleries Ltd, Mazitar, Rangpo, Sikkim and marked as Exhibit A on which one bottle taken as sample and marked as A1
- (2) One navy blue colour Trolley bag in which SL -01 was kept.

I, ASI Prabir Karmakar s/o Gobinda Chandra Karmakar of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused persons to the effect that on 14.04.26 at 23:35 hrs received a source information from Paribahan nagar area under Matigara PS that two persons was standing there with huge quantity of liquor in their possession for selling/Transporting the same in the open market at Bihar for their wrongful gain without any documents/license. Diarized the fact in GD vide Matigara PS GDE No-774 dated 14.04.26. Accordingly, informed the matter of I/C PS and as per his kind instruction myself along with ASI Bikash Roy, ASI Dipak Chhetri, C/523 Sanjib Kundu, C/219 Sanatan Chitrakar & C/868 Sujal Roy proceeded to the PO to work out the information. At 23:45 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from their possession. On interrogation it came to learn that they are collecting huge quantity of liquor from Sikkim for Transporting/selling the same in open market at Bihar for their wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from their possession after prepared proper seizure list and arrested them u/s 35 BNSS after issuing proper arrest memo and ground of arrest in written (The seizure was made in between 23:50 hrs to 00.07 hrs) the whole seizure was conducted under proper audio video record.

I therefore request you a specific case may kindly be started against the arrested accused persons namely (1) Md Rashid-24yrs s/o Lt Md Jainuddin of Kaluajote, PO+PS Naxalbari Dist Darjeeling and (2) Kishan Sarki-21yrs s/o Dipen Sarki of Bagrakote TG, Bank Line, PS Malbazar Dist Jalpaiguri under proper section of law and arrange for its investigation.
