Sir,

In producing herewith one arrested accused person namely Rohit Mahato-19 yrs s/o Lt Sukdev Mahato of Biswas colony, near Rail Gate, PS Matigara Dist Darjeeling (not verified) along with the following seized articles under seizure as per seizure list:

1. One (01) plastic zipper packet containing with 267 grams of suspected to be brown sugar & marked as- Exhibit-A.
2. One i-phone having IMEI No-351104518800805 & 351104511890472 with sim No-7866969155.
3. One Vivo mobile phone having IMEI No-864466077843454 & 864466077843447
4. 30 (Thirty) pcs of Indian currency of Rs-200 in denomination with 30X200=6.000/
5. 90 (Ninety) pcs of Indian currency of Rs-100 in denomination with 90X100=9.000/  
Total-15.000/

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 16.04.26 at about 14.10 hrs, I received a reliable source input that one person has gathered with huge quantity of brown Sugar in his house for delivering the same to his designed customers at Biswas colony for his wrongful gain. It is reasonably believe that the person may escape from the scene if Police party did not reach the spot immediately. The matter was diarized in Matigara PS GDE vide No. 860 dated 16.04.26 and subsequently, I informed the matter to the I/C Matigara PS, SPC in writing and being directed by him, At about 14.15 hrs myself along with ASI Bikash Roy, ASI Dipak Chhetri, ASI Chandra Prakash Adhikary, ASI Prabir Karmakar, C/523 Sanjit Kundu, C/868 Sujal Roy, & L/C-1286 Anisha Chhetri all of Matigara PS with investigation kit (envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc. left for Biswas colony, near Rail Gate under Matigara PS by govt. hired vehicle to verify the veracity of the information vide Matigara PS GDE no. 861 dated 16.04.26 and M.C.C No- 1088/26 Dated 16.04.26.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter at 14.30 hrs we reached in front of Biswas colony near Rail Gate and waiting there also I called two independent witnesses namely; (1) Tear Barman-26yrs (Ph-9083375154) s/o Kamini Barman of Bhangapool, Himul PS Matigara Dist Darjeeling and (2) Md Sahil-33yrs (Ph-9144307761) s/o Lt Md Chaidul of Darjeeling more, Green Park,

near Kali Mandir PS Pradhannagar Dist Darjeeling disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure.

At about 14.34 hrs I also informed Videographer Somnath Chatterjee (ph-9064648755) s/o Sushil Chatterjee of Aravindapally, Gokhel road, ward no-22 PS Siliguri dist Darjeeling over telephone to remain present at the PO for videography during search and seizure if any.

At about 14.44 hrs Videographer Somnath Chatterjee reached at the spot with camera. Being identified by my source we detained the above noted person with. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person stated that he is possessing "Brown Sugar" with him. Being identified by source and the information in hand and stated him that he will be searched for the purpose by me. He admitted that he had illegally possessed brown sugar in his possession for selling the same to his designed customers as per requirement for his wrongful gain. During raid his mother Kanti Mahato w/o Lt Sukdev Mahato of Biswas colony, near Rail Gate PS Matigara Dist Darjeeling fled away from the spot through back side open window.

I then gave an option in writing whether he will willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return he given written reply that he is willing to be searched in presence of Gazette Police Officer. Then at about 15.20 hrs I informed over telephone to Shri Manojit Sarkar, Inspector In-Charge, Matigara Police Station to come at Biswas colony near Rail Gate requested him to presence during search and seizure of the Brown Sugar.

Accordingly at 15.30 hrs Shri Manojit Sarkar, Inspector In-Charge, Matigara Police Station arrived at the spot as Gazette Police Officer and subsequently, under his supervision in presence of witnesses the process of search of the detained person for conducted following all formalities and recovered the above noted articles from the exclusive possession of Rohit Mahato-19 yrs s/o Lt Sukdev Mahato of Biswas colony, near Rail Gate, PS Matigara Dist Darjeeling. Subsequently, being demanded in presence of Shri Manojit Sarkar, Inspector In-Charge, Matigara PS as Gazetted Police Officer the detained person failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found total 267 grams Said to be Brown Sugar and (1) One i-phone having IMEI No-351104518800805 & 351104511890472 with sim No-7866969155. (2) One Vivo mobile phone having IMEI No-864466077843454 & 864466077843447 (3) 30 (Thirty) pcs of Indian currency of Rs-200 in denomination with 30X200=6.000/ (4) 90 (Ninety) pcs of Indian currency of Rs-100 in denomination with 90X100=9.000/ Total-15.000/which was kept inside in his pocket.

Then, I seized the above noted articles at the spot under proper seizure list duly signed by the independent witnesses and accused person. I also labeled and sealed all the articles under the supervision of Shri Manojit Sarkar, Inspector In-Charge of

Matigara PS and witnesses and lady accused. The whole process of search & seizure has been audio & VDO graphed by videographer Sri Somnath Chatterjee. The whole process of seizure was made in between 15.50 hrs to 16.15 hrs.

Then, I arrested the above noted accused person namely Rohit Mahato-19 yrs s/o Lt Sukdev Mahato of Biswas colony, near Rail Gate, PS Matigara Dist Darjeeling after observing all formalities and informing the ground of his arrest in written and issued necessary Memo of Arrest u/s 35 (3) of BNSS. On interrogation he stated that his mother procured the seized Brown sugar from Chopra/Ramganj for selling the same to their customers. His mother Kanti Mahato w/o Lt Sukdev Mahato of Biswas colony, near Rail Gate PS Matigara Dist Darjeeling was dealing this business. She collected brown sugar from Chopra/Ramganj and arrested accused Rohit Mahato selling the same.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons namely Rohit Mahato-19 yrs s/o Lt Sukdev Mahato of Biswas colony, near Rail Gate, PS Matigara Dist Darjeeling (not verified) and his mother Kanti Mahato w/o Lt Sukdev Mahato of Biswas colony, near Rail Gate PS Matigara Dist Darjeeling is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act.




