Sir,

In producing herewith one arrested accused person namely Hanny Raj-20yrs s/o Pankaj Kumar Singh of Akhtiyarpur, PO Bhanborhan, PS Mahua Dist Baishali Bihar along with the following seized articles as per proper seizure list viz:

- (1) 12 (Twelve) bottles of Magic moments Green apple Flavored Vodka each bottle containing 750 ML (09 Ltrs) Blended and bottled by Sikkim distilleries and marked as Exhibit -A on which one bottle taken as sample and marked as A1
- (2) 24 (Twenty four) bottles of Magic moments Grain Vodka each bottle containing 750 ML (18 Ltrs) Blended and bottled by Sikkim distilleries and marked as Exhibit- B on which one bottle taken as sample and marked as B1
- (3) One Vivo mobile phone having IMEI No-865159073644351/00 with sim no-9334510338
- (4) One Blue colour without number -E/Rickshaw
- (5) Three black colour bag which SL No-01 to 2 was kept)

I, SI Srimanta Chatterjee s/o Lt Debi Prasad Chatterjee of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 18.04.26 at 19.10 hrs received a source information from National highway -10 side under Matigara PS that one person was coming towards city center driven by a blue colour E/Rickshaw (Without number plate) with huge quantity of liquor in his possession for selling/Transporting the same in the open market at Bihar for his wrongful gain without any documents/license. Diarized the fact in GD vide Matigara PS GDE No-1996 dated 18.04.26. As per your kind instruction myself along with ASI Bikash Roy, ASI Dipak Chhetri, C/523 Sanjib Kundu, C/219 Sanatan Chitrakar & C/868 Sujal Roy proceeded to the PO to work out the information vide Matigara PS GDE No-1997 dated 18.04.26 . At 19.35 hrs we reached at National highway-10, opposite Promodnagar, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. On interrogation it came to learn that he is collecting huge quantity of liquor from Sikkim for Transporting/selling the same in open market at Bihar for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him u/s 35 BNSS after issuing proper arrest memo and ground of arrest in written (The seizure was made in between 20.20hrs to 21.05 hrs) the whole seizure was conducted under proper audio video record.

I therefore request you a specific case may kindly be started against the accused person namely Hanny Raj-20yrs s/o Pankaj Kumar Singh of Akhtiyarpur, PO Bhanborhan, PS Mahua Dist Baishali Bihar under proper section of law and arrange for investigation..
