Sir,

In producing herewith one arrested accused person namely Ujjal Barman @ Dipjal-22yrs s/o Raj Kumar Barman of Sishabari, Mauriya busty, PO New Rangia, PS Matigara Dist Darjeeling with seized articles viz. (1) one improvised country made fire Arms fitted with trigger, which barrel in length approx 4" and butt in length approx 5 ½" (Made of iron) and marked as Exhibit-A (2) Two live ammunitions approx 3" and marked as Exhibit-B

I ASI Bikash Roy of Matigara Police Station do hereby lodge this written complaint against the above noted accused person to the effect that on 19.04.26 around 20.25 hrs received a Secret information from my source that one person is suspiciously moving in and around Matigara Tea Estate beside Flyover under Matigara PS with illegal fire arms. Diarized the fact in GD vide Matigara PS GDE No- 2061 dated 19.04.26. Accordingly, I informed the intelligence to I/C Matigara PS and under his direction I proceeded to work out the information. At 20.40 hours We arrived at Matigara Tea Estate beside Flyover, again contacted with my source and being indicated and identified by him, I along with my team accompanied with ASI Prabir Karmakar, ASI Dipak Chhetri, ASI Chandra Prakash Adhikari, C/523 Sanjit Kundu and C/868 Sujal Roy all of Matigara PS surrounded one 22/24 years aged person without any delay we apprehended him and disclosed our identity as the police personnel of Matigara PS. During raid no one present in the spot. On examination the detained person disclosed his name and identity as noted above and also disclosed the information at hand in presence of the passersby available around the spot. Without delay we held search of his person in presence of available witnesses and recovered one improvised country made fire Arms fitted with trigger, which barrel in length approx 4" and butt in length approx 5 ½" (Made of iron) and (2) Two live ammunitions approx 3" which was concealed in his left waist. On interrogation the accused person made incoherent statement regarding possession of the ammunitions. He stated that he procured the ammunitions from one unknown person for selling the same. On demand he failed to produce any license/documents in respect of those fire arms.

In presence of the witnesses I seized the recovered above noted ammunitions under proper seizure list duly signed by the witnesses and the accused person after preparing label after proper audio & VDO gapped. Accordingly, I arrested the accused Ujjal Barman @ Dipjal-22yrs s/o Raj Kumar Barman of Sishabari, Mauriya busty, PO New Rangia, PS Matigara Dist Darjeeling for violation provisions under Arms Act. Ground of arrest also informed to the accused person and issued proper arrest memo. Seizure was made on 19.04.26 in between hrs 21.05 hrs to 21.35 hrs.

On the above circumstances, I pray that a specific case under proper section of Arms Act. may kindly be started against the accused Ujjal Barman @ Dipjal-22yrs s/o Raj Kumar Barman of Sishabari, Mauriya busty, PO New Rangia, PS Matigara Dist Darjeeling and arrange for its investigation.
