In producing herewith following four arrested accused persons namely (1) Sourav Das-30yrs s/o Kartick Das of Rangapani, Dhodijote, PO- Ranidanga ,PS- Bagdogra, Dist Darjeeling (2)Md.Tahir Alam-25yrs approx, s/o Md Majibar Rahaman of Moqbul Busty, Panchkelguri, PO-New Chamta,PS Matigara, Dist- Darjeeling (3) Suman Kharia @ Ajit Kharia-29yrs approx, S/o Lt. Goutam Kharia of Chandmani Matigara Chumta Line,PO+ PS Matigara, Dist Darjeeling along with following seized articles viz:

- 1) One iron made sabol measuring approx. 2 ½ feet recovered from the exclusive and Conscious possession of Sourav Das.
- 2) One iron made Hakshaw blade with Handel measuring approx.1feet recovered from the exclusive and Conscious possession of Md Tahir Alam.
- 3) One iron made Iron made plus measuring approx 8 inch recovered from the exclusive and Conscious possession of Suman Kharia @ Ajit Kharia.

I, ASI Dipak Kr. Chhetri of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and 4/5 others to the effect that on 19.04.2026 at 23:40 hrs received a specific source information that 8/9 miscreants have assembled at Himachal Vihar near APC Roy Govt. College under Matigara PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Matigara PS and diarized the fact in General diary vide Matigara PS GDE No-2072 dated 19.04.26 and as per order I along with, ASI Chandra Prakash Adhikari, C/523 Sanjib Kundu, C/868 Sujal Roy and C/219 Sanatan Chitrakar all of Matigara PS, SPC, left for Himachal Bihar near APC Roy Govt.college under Matigara PS to work out the information in hand. This refers to Matigara PS GDE No-2072 dated 19.04.26

At about 23:50 hrs we arrived at Himachal Bihar near APC Roy Govt. college under Matigara PS as indicated by the source we noticed that 8/9 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 03 (three) of them with deadly weapons in their possession but 4/5 persons managed to fled away from the spot taking the advantage of darkness and open place.

On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession. On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the
