Sir,

This is to inform you that a gang of B.J.P. Goons attacked upon our party workers at around 5:30 p.m. today near Mukta Nursing Home in Shivmandir. While our women workers were coming to attend a meeting in our nearby Office the goons from the bike rally started outraging their modesty. Listening to the noise our male workers rushed to rescue the women. A gang of 200 members instantly started beating all the men & women workers with iron rods / bamboo / wooden sticks and pelted stones on them. As a result many of our male and female workers sustained severe injury and have been rushed to the N.B.M.C.H. and Matigara B.P.H.C. Two persons are grievously injured and struggling for life at N.B.M.C.H.
