**(Sub- Obstruction in distribution of Election Manifesto, physical assault, attempt to attack with weapon (daw) and death threats by TMC supporters.)**

Sir, I Mr. Ratan Sharma (Advocate), Convenor – BJP District RTI cell, wish to report that on at around, while our karyakartas were distributing the election manifesto/ Modi ji Sankalp Patra door to door in Goriya Math, Uttar Ektiyasal, Near Gobinda Rai House, under 19 Dabgram Fulbari Vidhansabha area, some TMC supporters/leaders led by Uttam Barman and his associates (name of all the persons is given below) wrongfully obstructed our supporters from distributing the manifesto yesterday i.e. 19/04/26, around 3.30 P.M.

They assaulted our party karyakartas. One TMC supporter named Uttam Barman tried to attack our karyakartas with dao (Sharp weapon). Our workers were also threatened and intimidated.

Further, they (Uttam Barman and Bishnu Rai and others) gave death threats to our workers saying they would be killed after the election counting on 4<sup>th</sup> May.

This is a serious offence and violation of the Model Code of Conduct. Therefore, I request you to kindly lodge an F.I.R. against Uttam Rai and other associates (Name, Father/Guardians Name and address given below) under relevant Sections of Bhartiya Nyaya Sanhita for assault, criminal intimidation, attempt to cause hurt with dangerous weapon and obstructing election process and take immediate legal action.
