Respected Sir,

With due respect, I, **Bhajan Sarkar** son of Lakshan Sarkar, resident of Dhauliguri, P.O. & P.S. Gossaigaon, District Kokrajhar, Assam, PIN – 783360, most respectfully submit as follows:

1. That I am the father of my minor daughter, namely **Guriya Sarkar**, aged about 16 years.
2. That on 16.04.2026, my wife Tumpa Sarkar, my son Dhananjay Sarkar, and my aforesaid daughter namely Guriya Sarkar came to Siliguri to visit her maternal aunt residing at Durga Nagar, Siliguri.
3. That I arrived at Siliguri on 17.04.2026 to take my family members back to home in Assam.
4. That on the next morning i.e., 18.04.2026, when I asked my family members to get ready for departure, we discovered that my daughter was missing from the house.
5. That despite making thorough searches in the house and surrounding areas, and with the assistance of local residents, we were unable to trace her whereabouts. Her mobile phone was also found left behind at the house.
6. That after thorough search, some local persons informed us that they had seen my daughter with an unknown men.
7. That after gathering information, I came to know that one Abhi Roy, aged about 25 years, is suspected to have kidnapped my daughter for wrongful gains.
8. That the said Abhi Roy had previously attempted to abduct and influence my daughter for his wrongful gain. In this regard, I had earlier lodged a written complaint against him on 23.06.2023 at P.S.

Gossaigaon, District Kokrajhar, Assam. His mobile number is 7628022262.

9. That my daughter is a minor, innocent, and vulnerable, and I have strong apprehension that she has been wrongfully taken away and is in danger.

I pray before you to take immediate action to trace and recover my daughter as soon as possible as the said Abhi Roy is a child Predator.
