I, **RIYA BARAI**, W/O Mintu Sarkar, D/O Krishna Barai, Resident of Gram Bhotepara, P.O. Kundar Dighi, P.S. Bhorer Alo, Dist- Jalpaiguri, do hereby want to inform you as follows: -

1. That I lodge this F.I.R. to the effect that I **RIYA BARAI**, W/O Mintu Sarkar, D/O Krishna Barai was married with **MINTU SARKAR**, S/O Sunil Sarkar, resident of No. 12, Lelin Colony, Sarat Chandra Pally, Haiderpara, P.O. & P.S. Bhaktinagar, Dist- Jalpaiguri, Pin- 734006, (mobile no 8101225382) on 19.03.2026 as per Hindu rites and customs.
2. That I lodge this F.I.R. to the effect against my matrimonial house are my husband **1. MINTU SARKAR**, Son of Sunil Sarkar, **2. SUNIL SARKAR**, my father-in-law, **3. SUSHMA SARKAR**, Wife of Sunil Sarker, mother in law, **4. MINTU SARKAR**, Son of Sunil Sarkar, elder brother-in-law and **5. PINTU SARKAR**, Son of Sunil Sarkar younger brother-in-law, **6. GANESH MANDAL**, (Ghatak) of the marriage; except accused no 6, all are resident of No. 12, Lelin Colony, Sarat Chandra Pally, Haiderpara, P.O. & P.S. Bhaktinagar, Dist- Jalpaiguri, Pin- 734006 and accused no 6 is the resident of Vill- Chakiavita, P.O. Kamarvita, P.S. Bhorer Alo, Dist- Jalpaiguri, Pin- 735135.
3. That in the month of January, 2026 one **GANESH MANDAL** who introduced himself as a "Ghatak" of marriage, approached my father for arranging the marriage between me and **MINTU SARKAR**, S/O Sunil Sarkar, resident of No. 12, Lelin Colony, Sarat Chandra Pally, Haiderpara, P.O. & P.S. Bhaktinagar, Dist- Jalpaiguri, Pin- 734006, (mobile no 8101225382), subsequently in the last week of February, 2026 my husband **1. MINTU SARKAR**, father-in-law namely **2. SUNIL SARKAR**, mother in law **3. SUSHMA SARKAR**, elder brother-in-law **4. MINTU SARKAR**, and younger brother-in-law namely **5. PINTU SARKAR** came to my parental house and subsequently the marriage between me and my husband was finalized.
4. That during the marriage negotiations, my husband **1. MINTU SARKAR**, father-in-law namely **2. SUNIL SARKAR**, mother in law **3. SUSHMA SARKAR**, elder brother-in-law **4. MINTU SARKAR**, and younger brother-in-law namely **5. PINTU SARKAR** demanded cash dowry of Rs. 2,00,000/- (Rupees Two Lakh only) from my parents, and my father has given the cash dowry of Rs. 2,00,000/- (Rupees Two Lakh only) to my husband and my father in law. Moreover, Godrej Almirah, gold ornaments worth Rs. 2,00,000/- (Rupees Two lakhs only), which has been handed over to my husband and my father in law, in presence of the other relatives on the day of marriage i.e., on 09.03.2026.

5. That in this regard I would like to state that our marriage is an arranged marriage which has been arranged by one **GANESH MANDAL**, who introduced himself as "Ghatak", resident of Vill- Chakiavita, P.O. Kamarvita, P.S. Bhorer Alo, Dist- Jalpaiguri, Pin- 735135 and it is also to be mentioned here that there is a Ten (10) years age difference between me and my husband but I gave my consent hoping that everything will be taken care by my husband but all my expectations are in vain as my husband and in-laws as mentioned above used to torture me both mentally and physically and pressurized me to bring money from my father and when I refused to comply their demands my husband, my in-laws as mentioned above, started to torture me, beat me mercilessly and used abusive languages upon me in respect of my skin complexion.
6. That soon after marriage I started to realize that there is some physical problem of my husband as my husband has had no interest upon me and my husband used to ignore me in respect of physical relationship and when I urged my desire for having physical relation with my husband, my husband become furious and started to abuse me with filthy languages and forced me to sleep in a separate bed.
7. That when I asked the said matter to my in-laws as mentioned above, they also forced me to keep this matter silent and threaten me that if I disclose the matter of physical ability of my husband to anyone, then they will kill me.
8. That day by day, the level of torture towards me increased and I was abandoned in my matrimonial house, as my husband disconnected all the relations with me inspite of living in the same roof.
9. That subsequently one night, I discovered that my husband is incapable of having physical relation with anyone and when I asked my husband that why he married me inspite of having the knowledge that he is incapable of sexual intercourse, at this my husband become furious and started to beat me with kicks and blows and my husband banged my head on the wall and I lost my sense.
10. That after that when I express the matter to my above named in-laws, I become surprised to know that all my in-laws as mentioned above have full knowledge about the incapability's of my husband and having the said knowledge, my husband 1. **MINTU SARKAR**, father-in-law namely 2. **SUNIL SARKAR**, mother in law 3. **SUSHMA SARKAR**, elder brother-in-law 4. **MANANTU SARKAR**, and younger brother-in-law namely 5. **PINTU SARKAR** and the said "Ghatak", cheated me and my family members and by suppressing the said truth of the physical incapability's of my husband, they arranged my marriage with my husband by way of **cheating** and the above noted persons in connivance amongst them only to **misappropriate** the stridhan articles destroyed my life in all aspects.

11. That after that whenever I want to visit to my parental house, my husband and my other in laws threaten me that if I disclose the said matter of physical incapability's of my husband to anyone then they will not only kill me and my parents but also implicate us in false cases. Moreover, my husband and my in-laws forced me to leave my matrimonial house permanently and my husband continuously threatened me that if I refuse to go to my parental house for bringing enough dowry, my other family members will arrange a second marriage of my husband and my husband also threatened that he will leave me and whenever I requested my husband to take me to my parental house during the weekends my husband used to beat me mercilessly and also used abusive languages on me and my parents and upon such continuous mental and physical torture by my family and father in-law and their threats I was forced to confine myself in their said house.
12. That subsequently in the first week of April, 2026, my husband and my in-laws forced me to take some pills and as soon as I consumed the said pills forcefully, I lost my sense and when I regain my sense, my husband and my above noted in-laws threaten me that I have to accept my husband as he actually is and if I denied to do so then they will circulate my nude picture which they have captured when I was unconscious because of the said medical pills.
13. That moreover after passing of time I revealed that my husband having relationship with a man and when I tried to ask my husband about the said relationship with the said male person, my husband got furious and started to beat me and mercilessly, also clearly expressed that they love each other and they will kill me and will marry with each other.
14. That thereafter on 09.04.2026 when I was doing my household work and asked my husband to help me, my husband without any reason started to abuse me in filthy languages, threw the slipper on me and also spitted on my face and when I protested against these activities and tried to escape then my husband caught hold of my hair, dragged me on the floor and beat me fists and blows mercilessly, by strangulate my neck, by tight my feet, sat in my chest and put the pillow on my face with an intention to kill me due to that effect I lost my sense and my husband spear me considering that I was dead.
15. That I finding no other alternative informed the said matter to my parents and my sister upon hearing about all these incidents came to see me at my matrimonial house but my husband got furious upon seeing my father, mother, and sister and started to humiliate them by using abusive languages and beat me in front of them with fist and blows and my father in law throw me in that condition and my father, mother and sister out of matrimonial house and since then I was forced to live in my matrimonial house.

16. That presently my husband and father in law started to threat over telephone that if I disclose the matter of physical incapability of my husband then they will implicate me and my parents in false cases.

17. That my husband 1. **MINTU SARKAR**, father-in-law namely 2. **SUNIL SARKAR**, mother in law 3. **SUSHMA SARKAR**, elder brother-in-law 4. **MANSANTU SARKAR**, and younger brother-in-law namely 5. **PINTU SARKAR**, in connivance with **GANESH MANDAL** "Ghatak", will remarry my husband and destroyed my life.

18. That at present I am living in very depressed condition and I have become mentally and emotionally ruined due to the above mentioned inhuman, cruel acts and conducts of my husband namely 1. **MINTU SARKAR**, father-in-law namely 2. **SUNIL SARKAR**, mother in law 3. **SUSHMA SARKAR**, elder brother-in-law 4. **MANSANTU SARKAR**, and younger brother-in-law namely 5. **PINTU SARKAR**, (Ghatak) of the marriage 6. **GANESH MANDAL**; except accused no 6; all are resident of No. 12, Lelin Colony, Sarat Chandra Pally, Haiderpara, P.O. & P.S. Bhaktinagar, Dist- Jalpaiguri, Pin- 734006 and accused no 6 is the resident of Vill- Chakiavita, P.O. Kamarvita, P.S. Bhorer Alo, Dist- Jalpaiguri, Pin- 735135 and subsequently I become mentally sick and presently I am in a trauma and have to take some neuro medicines in consultant with Dr. Arunima Ghosh since 20.04.2026.

I therefore request before your good self to kindly look into the matter and take strict necessary action against my husband namely 1. **MINTU SARKAR**, Son of Sunil Sarkar; 2. **SUNIL SARKAR**, my father-in-law, 3. **SUSHMA SARKAR**, Wife of Sunil Sarker, mother in law, 4. **MANSANTU SARKAR**, Son of Sunil Sarkar, elder brother-in-law and 5. **PINTU SARKAR**, Son of Sunil Sarkar younger brother-in-law, 6. **GANESH MANDAL**, (Ghatak) of the marriage; except accused no 6, all are resident of No. 12, Lelin Colony, Sarat Chandra Pally, Haiderpara, P.O. & P.S. Bhaktinagar, Dist- Jalpaiguri, Pin- 734006 and accused no 6 is the resident of Vill- Chakiavita, P.O. Kamarvita, P.S. Bhorer Alo, Dist- Jalpaiguri, Pin- 735135, as per the provision of law and for this act of kindness I shall remain extremely grateful to you.
