Santashi Nagar, ward No. 05, P.O. Siliguri Bazar, P.S. Siliguri, Dist.
Darjeeling - 734005.

That on 23/04/24 at around 11:00 am to 11:30 am while at my house
when we heard loud noises from the street, upon which
we and my husband went outside to discover what was
happening, we found that the above named persons were
beating my nephew namely Lalam Sahani, in relation to the
my husband's big brother's son. We then went to stop the
said persons saying why they were beating him with
purses slaps and paricals they pushed us away saying not
to interfere, in meantime, the local people intervened and
somehow everyone were able to stop Baby Sahani, Karan Sahani
and Golu Sahani.

Having thought that everything was resolved everyone went
home and when we returned to our house, the said persons
followed us, the said Karan Sahani punched me on my right eye
and started to touch my blouse and tore it saying this is my
husband's blouse and pushed him away, so such on
said Baby Sahani took an iron water bucket and threw it
towards Golu Sahani and hit it behind the head of my husband
and when I screamed at this seeing my husband bleed
local people came and seeing this the said person ran away
Me and my husband thereafter went to Siliguri District
Hospital for our medical injuries, due to my medical
condition and body injury I am lodging this FIR today.
Kindly investigate into this matter and come up
with speedy justice.
