Subject: Complaint regarding assault causing grievous injury and damage to property.

Respected Sir/Madam,

I, **Sujit Gupta**, S/O Late Prabhu nath prasad , R/o Nehru road Khalpara Near Khemchand Building P.O & P.S siliguri Dist- Darjeeling, respectfully submit this complaint as follows:

That I was married to my wife ~~Ritu Gupta~~ ^{Roshni}, however due to matrimonial disputes, she has been living separately from me for the past one year.

That with the intention to resolve the matrimonial dispute amicably and to seek assistance for a peaceful separation/divorce, I approached my relatives, namely, **Gopal Gupta** and **Abhinew Gupta** Who are related to my wife and had also earlier acted as intermediaries /marriage arrangers between the families.

That on 23rd April at about 7:00 PM, I went near Arogya Niketan Nursing Home, situated on S.P. Mukherjee Road (Khalpara), Ward No. 9 of (S.M.C) P.O.& P.S Siliguri solely for the purpose of discussing and resolving the matter peacefully.

That upon my arrival, the above-named persons, along with others present there, acting in furtherance of their common intention, suddenly and without any provocation started physically assaulting me by repeatedly hitting me with fists and slapping me multiple times.

That due to the said assault, I sustained serious injuries including a fracture in my right hand. They have also damaged my personal property by breaking my **mobile phone, watch** and tearing **my clothes**.

That during the incident, they attempted to further escalate the assault by trying to use a chairs and thick sticks and other stuffs to further harm me however, I somehow managed to escape from the spot to save myself. A local councilor of the area, associated with a political party (BJP), was also present along with them and one of his associates, actively participated in assaulting me.

That I have reason to believe that the said incident was not sudden but premeditated, and that my wife had prior knowledge of my visit. I further have reason to believe that the

accused persons were instigated beforehand, and that they were prepared to assault me in the event of my visit. That due to this incident, I have suffered physical injuries, mental trauma, and financial loss.

Therefore, I humbly request you to kindly register my complaint/FIR against the accused persons and take immediate legal action against Gopal Gupta and Abhinew Gupta and the other persons involved.

I am ready to cooperate fully and provide medical reports, evidence, and any further information as required.

I shall be grateful for your prompt action.
