Subject: Complaint against Sri Rajesh Saraf son of Shiv Pujan Saraf

Sir,

I, Sri Raj Kumar Sah, permanent resident of R.P. Sarani Road, Dangipara, Ward No. 6 of Siliguri Municipal Corporation, Siliguri, Post Office and Police Station- Siliguri, Pin- 734001 and presently residing at Shastri Nagar, ward no. 41 of Siliguri Municipal Corporation, Siliguri, Police Station- Bhaktinagar, would like to draw your kind attention to the fact that on 23.04.2026 at around 12.30 P.M. when I along with my wife came for voting at Dr. Rajendra Prasad Girls High School, I received a call from one of my friend Md. Anwar Hussain asking me to come to Quereshi Mohallah and when I reached there I found that there was some altercation going on between the said Rajesh Saraf son of Shiv Puja Saraf resident of Gurung Basti, Post Office and Police Station- Pradhan Nagar and Md. Anwar Hussain regarding some monetary transaction to which I was witness and the said transaction occurred in my presence..

On reaching Qureshi Mohallah, when I supported the claim of Md. Anwar Hussain of giving personal loan to Rajesh Saraf in front of Rajesh Saraf wife, the said Rajesh Saraf become furious and started using offensive and vulgar language at me and Md. Anwar Hussain, further slapping me, kicking me in my stomach, physically torturing me and further threatening to make me spend rest of my life in jail in presence of the local people.

When I, Md. Anwar Hussain along with local people protested the said Rajesh Saraf started to threaten us by stating that I am Vice President of Tourism Association of India and have good relation with politician and connection with high rank police official and started to tear his own shirt and filed a false case against me and Md. Anwar Hussain in which I was arrested on 23.04.2026 by the Siliguri Police and was enlarged on bail on 24.04.2026 by the Ld. A.C.J.M Court at Siliguri.

Sir, after my release from Court I came across a video in CONNECT PRIME + social media channel (<https://www.facebook.com/share/v/1G2okdP4Dj/>) where the same incident has been described and in the said video the said Rajesh Saraf have alleged that because of the Muslim community he has left his parental house years ago and the 10/12 Muslim community person have hit me and whereas in the said FIR there is no mentioned of the said statement (a copy of the said FIR filed against me is enclosed herewith) and in the said video he has also stated that he has called Shankar Ghosh (M.L.A Candidate from B.J.P) proving his contention of having political links.

Sir, in the said FIR filed against me the said Rajesh Saraf has mentioned his residential address as Ganja Gali, Quereshi Mohallah the place which he alleged to leave because of Muslim Community. Moreover, his family members happily live in the said house till today and in the said FIR the said Rajesh Saraf stated that he with the help of Central Force managed to escape whereas in the said video, the said Rajesh Saraf is clearly seen giving bite to the media personal all alone without any fear near Dr. Rajendra Prasad Girls High School and further stating that he is waiting for Shankar Ghosh.

In the above scenario, I request you to take necessary action against the said Rajesh Saraf for slapping me, kicking me, physically torturing me, threatening me, using defamatory and vulgar language at me, using purgative language in social media to instigate communal tension to gain sympathy from Hindu community people and by playing victim card whereas he is the main culprit and for defaming me and filing false case against me and others.
