Sub: Complaint of Murderous assault and injuries caused to me.

Dated. Siliguri the 28th of April, 2026.

Sir,

I, Amar Nath Gupta (65 Years) s/O Sri Pannalal Gupta. a resident of Nazrul Sarani, Ashrampara, Siliguri would like to lodge this complaint against two unknown assailants to the effect that I have a shop named " Bag and Bags" located at Bharat Bhawan, Beneath HDFC Bank, Sevoke More, Hill Cart Road, Siliguri-734001 from where I sale bags, trolleys, rucksack etc.

On 24.04.2026 at about 1800hrs two young men came to my shop and demanded to see a rucksack, I obliged and showed them the rucksack available at my shop at that time . They were not satisfied with the Brand / type of rucksack showed to them and they insisted on me to show other varieties of rucksack. As I told them that I had no other varieties to show them, they got irritated and started shouting at me using foul languages. I politely told them to leave my shop but suddenly they attacked me and hit me using their fists and blows. One of them who was holding a helmet in his hand assaulted me with it and the sharp edge of the helmet caused a sharp cut injury on the upper portion of my right eye causing profuse bleeding. The assailants then dragged me out of my shop and threw me down from the top of the stairs resulting in bodily pain and injuries. The miscreants then hurriedly left the spot.

The local people then rushed me to nearby Kins Hospital at Sevoke More where the sharp cut wound over my right eye was stitched.

Then I was rushed to Maya Nursing Home at Nazrul Sarani where after a thorough examination my Right shoulder bone was found dislocated due to assault. The attending doctor has bandaged my hand and I'm confined to my bed since then and am unable to pursue my daily business.

The entire incident has been captured by a CCTV put up there where the faces of the assailants have been captured. Copy of the CCTV footage is available with me.

As such I am lodgings this complaint in writing and request you to kindly take proper legal action against the miscreants.
