I, Krishny chhetri, wife of Zigme Bhutia,
resident of Prakash Nagar, Simbu Busty, Ward
No 42, Siliguri, Dist Jalpaiguri do hereby
state the following:

The accused ZIGME BHUTIA - 7001169003, SONU
KHARKA - 8710056052, YANGDHE N LHAMO BHUTIA
7865059483 all residing currently at
Stalin Nagar, road no 2, Upper Bagdogra.
Ever since our marriage my sister in law,
mother in law and husband have been asking
and demanding for dowry and have been
harassing me mentally, they threw me and my
husband out of their residence in 2021,
ever since our marriage I have majorly
taken care of all the finances and took care
of the household and my daughter's
expenses including her therapy expenses
as she is an 'AUTISTIC' child, all the clothes,
pocket expenses and travel expenses, he
barely spend few lakhs.

Ever since my mother in law and sister
in law used abusive language and threw
us out of their bagdogra residence, both
mother in law and sister in law has
visited my maternal house at odd
hours and has send voice notes with
abusive language.

Currently my husband has planned
to go to Israel with our assurance of "our
Autistic daughter", he and his family
always refused for social marriage
or registered marriage now he today
tried to issue unmarried certificate
from Panchayat and has been threatening
me for defamation and kidnapping
of our daughter and demanding 50
lakhs for signing the marriage certificate

My daughter is autistic with no speech and sleeping disorder, ever since her birth and therapy. I single handedly am bearing all the expenses.

He lives in my old building now has gone to his real home but keeps demanding vehicle right over my property.

I hereby request you to register an FIR under the relevant sections of the Bhautiya Nyaya Sarbitha (BNS), Section 4 of the Dumpy Act, including Section 351 (Criminal Intimidation), Section 498 A.

If my child goes missing without my knowledge aforementioned individuals will be directly held liable.
