Respected Sir,

I Sahil Khan (Mobile No.97349-00438) Son of Late Rama Mahato, resident of Gurung Basti, Ward No.03 of S.M.C., P.O. & P.S. Pradhan Nagar, Dist. Darjeeling, Pin-734003 beg to report you the following facts:-

1. That to-day on 18.04.2026 at about 7.300 A.M. to 7.45 A.M. there is a place near of Heritage Hotel where some persons namely (i) Shankar Sharma son of Unknown, resident of Mallaguri, Near-Bangla School, P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling, (ii) Roshan Chhetri son of Unknwon resident of Champasari, P.O. & P.S. Pradhan Nagar, Siliguri, Dist. Darjeeling and 4 persons their associates, were started to create nuisance and insulted me by using unparliamentarily words abusing very filthy languages when I along with my passenger to having cup of tea near Heritage Hotel and their associates (Goons) suddenly Physically assaulted me brutally attacked with fists and blows and by lathi and leather belt got severe injury of my person near of Heritage Hotel, P.O. & P.S. Pradhan Nagar, Dist. Darjeeling.

After that I went to the Siliguri District Hospital, Siliguri, Dist. Darjeeling for medical treatment.

During such operation, they snatched Rs.3,500/- (Rupees Three Thousand Five Hundred) from my pocket.

Now, they are abusing me very filthy languages and threatening me by saying that if I go to the Police station to register/lodge any complain against them then they will murder me and drag my body outside from the city.
