1. That I am law abiding citizen of India and since more than 30 years without any objection, chaos I along with my family are residing in the land situated in the address mentioned above.

2. That today during evening time at about 7:00 PM while I was doing exercise in the school field which situated besides my house at Salbari namely Salbari High School all on a sudden some miscreants namely Md. Akbar, son of not known, Md. Halim, son of Halima Khatun, Md. Kamal, son of Lt. Md. Musarat Hussain (Lt. Lal Mohan) Md. Appu son of Alu & others all are resident of Salbari Naya Basti, leaded by simon lepcha, son of Partho Siring Lepcha also Md. Kamal son of Lt. Md. Musarat Hussain (Lt. Lal Mohan) all on a sudden attacked me with Iron rod, knife and lathi and assaulted me and also to my nephew namely Piku Chakraborty, son of Nepal Chakraborty and subsequently on raising halla, all the miscreants left the place with the threat that "we will kill you both and if you do not support the TMC Party and in this connection I state that out of the incident I and my nephew badly injured. It is also stated that on the earlier occasion the above named persons also attacked me with weapons and at that time I had lodged one written complaint but no action has been taken by the police station, the reasons best known to them. Now at this stage my life is in crises and as such I require your immediate help to ensure the life of myself and the life of my family members including my nephew and at the same time I also request to start specific criminal case against the above noted persons by initiating a criminal case and to arrest them immediately for committing the offence.

Hope you will extend your hands to ensure justice.
