**Subject:** FIR regarding damage to Government Vehicle by unknown person

Sir,

I Amanjeet Kumar, Junior Engineer respectfully submit that on 20.04.2026 at about 08:00AM at Champasari Rajaram MohanRoy bridge, an unknown person intentionally damaged a Government vehicle bearing registration No. **UP80 AG1219** by throwing a boulder.

The accused was riding a motorcycle bearing registration No. **WB74Q4340**. Due to this act, the rear (back side) glass of the vehicle has been broken, causing damage to Government property without any reason or provocation.

The incident occurred in presence, of our on duty driver sri Sanjit Kumar Das, and on duty Out sourcing security guard Sri Subhankar Nandi, who are eyewitnesses to the occurrence.

I would also like to inform you that **photographs and video footage of the incident and the accused person are available**, which is provided as evidence for investigation.

This act appears to be unlawful. Therefore, necessary action to be taken against the accused person.
