Respected Sir,

I, Sri Animesh Chakraborty @ Piku Chakraborty, Son
of Nepal Chakraborty, Resident of - C/O Joseph Chakraborty, Son
of Late Khageshwar Chakraborty, Salbari, Naya Busby, Post
Office - Methibari, within the Pradhan Nagar, District -
Darjeeling Pin - 734002 do hereby lodge this F.I.R
on the following effects with the request for taking
immediate action and arrest them immediately.

1. That I am law abiding citizen of India, I stay with
the family of my paternal uncle residing in the address
mentioned above.

2. That ~~today~~ during evening time at about 7:00 P.M. while I was going to market to purchase "Bulb" from my house above mentioned all on a sudden some miscreants namely Md. Kamal, son of Md. Musarat Hussain @ Late Lal Mohan and Md. Akbar, Md. Appu, attacked and stabbed my right hand with a very sharp object and assaulted me as a result I fell into the road, I was seriously injured and subsequently on raising halla all the miscreants left the place by saying "beche geli aaj k".

3. After the raising halla the local people and my jethu rush to the spot and resqued who were at the relevant time was nearby to the spot and I was taken to Siliguri Hospital immediately the Doctor after ascertaining the place of injuries, the doctor had made necessary treatment.

It is a place to mention here that few days before i.e. on 18.04.2026 the Champasari Gram Panchayat namely Md. Kamal, son of Md. Musarat Hussain @ Late Lal Mohan, and Md. Akbar, son of not known, Md. Appu under the control of Simon Lepda had threatened me and my Jethu i.e. Joseph Chakraborty by saying "if you do not support TMC Party we will kill you and your family" and after the said threat my jethu i.e. Joseph Chakraborty wrote written complaint against the Champasari Gram Panchayat namely Md. Kamal and his associates mentioned above and also mentioned in the written complaint duly attached but no specific criminal case registered against them.

Again on 22.04.2026 the said Champosari Gram Panchayat namely Md. Kamal threatened me by saying "This is your last warning if you do not support I will kill you" and subsequently I protest and as such on today i.e. on 24.04.2026 I got attacked.

Sir, after 2-3 days of threat caused by the Gram Panchayat and his associates being protest I got serious attacked with a sharp cutting object, with a plan and calculated way they tried to murder but luckily I got saved and now again I am lodging this written complaint against those persons.

4. I emphatically states that sustained several injury into my body and this dangerous act is not only an unwarranted but precedented too which should be stopped with the intervention by your department and at the same time it is requested to take adequate action against the Champosari Gram Panchayat namely Md. Kamal and his associates for committing the offences as stated above and to arrest them immediately by treating this written complaint as FIR starting a specific criminal case under the law of the land to ensure justice.

Hope you will extend your hands to ensure justice.
