**SUB: COMPLAINT REGARDING ASSAULT, INTIMIDATION AND  
CASTE BASED ABUSES**

Respected Sir ,

I, Simon Lepcha, S/o Late Patuk Tsheering Lepcha, resident of Chhetri Gaon Salbari, Nayabusty, P.O. Salbari, P.S. Pradhan Nagar, Dist- Darjeeling, Pin-734002, in the state of West Bengal respectfully submit the following for your necessary action please :-

That one Joseph Chakraborty, S/o late Khagesh Chakraborty, resident of the same locality in my neighbor and claims himself to be a Don of the locality, i.e Salbari, Nayabusty. Today (25.04.2026) at around 9am while I was buying some vegetables at Salbari bazaar - said Joseph Chakraborty along with his nephew Pintu Chakraborty S/o Nepal Chakraborty and one hired associate named Shivam Roy, without any provocation started abusing me in Filthy language. They threatened that they would not allow me to reside in the locality as I belong to a Scheduled Tribe Community. They further threatened that they would **capture my Dwelling House** if their Party come to power in the State.

That they also made derogatory and caste based remarks "Lapchey Gadhey" (Lepcha Donkey) and humiliated me in the presence of local residents namely Kamal Hussain S/o late Md. Musaraf Hussain, Md. Halim S/o late Md. Sarifuddin and others. When I protested against such behavior, they assaulted me.

That when the above mentioned local residents intervened to rescue and protect me, said Joseph Chakraborty shouted to local persons also asking them as why you "**Muslim People**" are helping this **bastard** Lepcha man.

However due to the strong protest of local residents they finally fled from the spot.

That the above acts are deliberate, unlawful and criminal in nature causing me severe physical pain, mental trauma, an emotional distress and posing a **serious threat to my life and safety.**

I, therefore humbly request you to register an FIR, conduct a proper investigation and take a stern legal action against the said miscreants accordance in law of the land.
