I, Appu Siddique, son of Abdul Mashid, resident of Nayabasty, near Chettri Gaon, Salbari, P.S. Pradhan Nagar, District Darjeeling – 734002, hereby lodge this First Information Report against the following persons for a brutal, unprovoked, and life-threatening attack on me: 1. **Joseph Chakraborty**, son of Late Khagesh Chakraborty, resident of Salbari, Chettri Gaon, Salbari 2. **Pintu Chakraborty (also known as Anivesh)**, son of Nepal Chakraborty, residing at the same address, 3. **Shiram Roy**, son of a person unknown to me, residing at the same address, 4. **Jonus Lepcha**, son of a person unknown to me, residing at the same address, and brother-in-law of Joseph Chakraborty, 5. **Two other unknown individuals associated with the above persons.**

APPU SIDDIK

Today at approximately 5:00 PM, while I was returning on foot from my grandmother's house located at Salbari Purana Busty, Salbari, I was passing near the house of Joseph Chakraborty in Salbari. My own residence is located at Nayabasty, adjacent to Chettri Gaon.

As I walked past the group, without any provocation or cause, Joseph Chakraborty and the others began to verbally abuse me using offensive language and slurs. I responded calmly, asking why they were abusing me since I had not committed any wrongdoing against them.

Suddenly, without further warning, all six men rushed towards me and began physically assaulting me. They punched and slapped me repeatedly. During this assault, Pintu Chakraborty pulled out a sharp knife, known locally as a "Khukri." While the others restrained my arms, neck, and legs, Pintu stabbed me on my left arm with the knife. The injury caused severe pain and bleeding.

Fearing for my life, I managed to break free from their grasp and ran towards my home, holding my injured left arm with my right hand. Upon reaching Nayabasty, some of my well-wishers who witnessed the attack helped me and immediately took me to Sukna Hospital in a Toto. At Sukna Hospital, I received urgent medical attention. The doctors treated my wound and had to stitch my left arm due to the deep cut caused by the stabbing. I am still recovering from both the physical injury and the mental trauma caused by this violent and unprovoked attack.

This incident clearly made me fear for my life. I respectfully request you to register this FIR and initiate strict legal action against the persons to ensure justice and prevent any further harm to me.
