Reasons for delay in reporting by the Complainant / Information i) 96 (ninety six) bottles of "HAYWARDS BOLD STRONG BEER" which were kept in 08 (eight) separate paper made cartoons each bottle containing 50 ml t.e, total (96 x 650 ml) = 62.4 ltrs - Marked as Exhibit - 'A' out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "A1". (ii) 108 (One hundred eight) bottles of "TUBORG PREMIUM BEER" which were kept in 09 (nine) separate paper made cartoons each bottle containing 650 ml t.e, total (108 x 650 ml) = 70.2 ltrs - Marked as Exhibit - 'B' out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "B1". (iii) 72 (seventy two) bottles of "Budweiser mugnum Beer" which were kept in 06 (six) separate paper made cartoons each bottle containing 650 ml t.e, total (72 x 650 ml) = 46.8 ltrs - Marked as Exhibit - 'C' out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "C1". (iv) 72 (Seventy two) numbers of Can Beer "Budweiser Premium King of Beer" which were kept in 03 (three) separate paper made cartoons, each can containing 500 ml i.e total (72 x 500 ml) = 36 ltrs - Marked as Exhibit - "D" out of which one bottle of the same taken as sample for examination and marked as Exhibit "D1" (v) 40 (forty) bottles of 60 Up Himalayan Gold India Made liquor which were kept in 02 (two) separate papers made cartoons, each bottle containing 600 ml i.e, total (40 x 600 ml) = 24 ltrs - Marked as Exhibit E, out of which one bottle of the same taken as sample for examination and marked as Exhibit "E1". (Total- Exb "A"- 62.4 ltrs + Exb- "B"- 70.2 ltrs + Exb "C"- 46.8 ltrs + Exb "D"- 36 ltrs + Exb "E"- 24 ltrs) = 239.4 ltrs.

Sir,
In producing herewith one accused person namely Ayush Kahar (20 yrs) S/O Subhash Kahar of Dharam Nagar, Coolipara, Ward No-01. PS- Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure list viz :-

(i) 96 (ninety six) bottles of "HAYWARDS BOLD STRONG BEER" which were kept in 08 (eight) separate paper made cartoons each bottle containing 650 ml t,e, total (96 x 650 ml) = 62.4 ltrs - Marked as Exhibit - 'A' out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "A1".

(ii) 108 (One hundred eight) bottles of "TUBORG PREMIUM BEER" which were kept in 09 (nine) separate paper made cartoons each bottle containing 650 ml t,e, total (108 x 650 ml) = 70.2 ltrs - Marked as Exhibit - 'B' out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "B1".

(iii) 72 (seventy two) bottles of "Budweiser mugnum Beer" which were kept in 06 (six) separate paper made cartons each bottle containing 650 ml t,e, total (72 x 650 ml) = 46.8 ltrs - Marked as Exhibit - 'C' out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "C1".

(iv) 72 (Seventy two) numbers of Can Beer "Budweiser Premium King of Beer" which were kept in 03 (three) separate paper made cartoons, each can containing 500 ml i,e total (72 x 500 ml) = 36 ltrs - Marked as Exhibit - "D" out of which one bottle of the same taken as sample for examination and marked as Exhibit "D1"

(v) 40 (forty) bottles of 60 Up Himalayan Gold India Made liquor which were kept in 02 (two) separate papers made cartoons, each bottle containing 600 ml i,e, total (40 x 600 ml) = 24 ltrs - Marked as Exhibit E, out of which one bottle of the same taken as sample for examination and marked as Exhibit "E1".

(Total- Exb "A"- 62.4 ltrs + Exb- "B" -70.2 ltrs + Exb "C"- 46.8 ltrs + Exb "D"- 36 ltrs + Exb "E"- 24 ltrs)
= 239.4 ltrs.

I, ASI Bikash Roy of Pradhan Nagar P.S, Siliguri Police Commissionerate would like to lodge this written complaint against the above mentioned arrested accused person namely Ayush Kahar (20 yrs) S/O Subhash Kahar of Dharam Nagar, Coolipara, Ward No-01. PS- Pradhan Nagar, Dist. Darjeeling to the effect that today on 26.04.26 at around 18.15 hrs I received a specific source information that one person namely Ayush Kahar of Dharam Nagar Ward No-01 under PS- Pradhan Nagar, Dist. Darjeeling is running illegal business of liquor and he is storred huge quantity of illegal liquor at his residence at Dharam Nagar Coolipara under PS Pradhan Nagar, Dist. Darjeeling. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 1569 dated 26.04.26 and informed the fact to you. As per your kind order and direction, myself along with SI Goutam Mallik of SB, SPC, ASI Biplab Kr Das, and force left for Daharam Nagar, Coolipara by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Dharam Nagar, I informed RT van Officer SI Abu Taleb and requested him to come to Dharam Nagar, Collipara to assist us and also informed one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, PS- Siliguri Dist. Darjeeling over mobile phone and requested him to come to Dharam Nagar, Coolipara with his camera to videograph the process of search and seizure if required. At around 18.35 hrs myself along with above mentioned officers and force arrived at Dharam Nagar Coolipra and contacted with my soure while form a considerable place he pointed the house of suspect who strroed huge quantity of illegal liquor. Then, I contacted with two local witness namely (i) Arun Sahani (25 yrs) S/O Upendar Sahani and (ii) Md Sabir (23 yrs) S/O Jawad Hossain both of Rejendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at the spot and act as witness if any search and seizure would be made upon which they agreed. After a while, RT van officer SI Abu Taleb and above mentioned videographer arrived at Dharam Nagar, Coolipara and accompanied with us. Then, I along with the above mentioned officers and force conducted raid at the residence of suspect Ayush Kahar and managed to apprehended him. Thereafter, we disclosed our identities as Police personnel (as 2/3 police personnel were in civil dress for our convenience) and informed him regarding the information in hand. On interrogation he disclosed his identity as noted above and on search the above noted articles are recovered from his possession.

On demand he failed to produce any valid documents in respect of the illicit liquor recovered from his possession. On further interrogation he stated that he collected the said quantity of illegal liquor clandestinely from one of his suppliers and for selling the same to his design customers in high rates for his wrongful gain. On further grilling, he confessed his guilt and stated that is running such illegal business of illegal liquor since few months for his wrongful gain. Then, I seized and labeled the above mentioned illegal illicit distilled liquor from his possession under proper seizure list and subsequently arrested the above mentioned detained person namely Ayush Kahar (20 yrs) S/O Subhash Kahar of Dharam Nagar, Coolipara, Ward No-01. PS- Pradhan Nagar, Dist. Darjeeling after observing all formalities of arrest, informing him regarding the ground of his arrest for violating the norms of Bengal Excise Act and brought to Pradhan Nagar PS for further investigation. I also issued copy of Memo of arrest and ground of arrest in written to him. The entire process of seizure and label has been made in between 19.25 hrs to 20.20 hrs on 26.04.2026 at the spot under the coverage of videography executed by the above mentioned cameraman as per norms of BNSS. Further, I informed his father namely Subhash Kahar regarding arrest of accused Ayush Kahar and also informed that accused Ayush Kahar will be forwarded before Ld ACJM, Siliguri on 27.04.26 at 11.00 hrs.

Under the above mentioned fact and circumstances, I therefore pray before your good self that a specific case may kindly be initiated against the arrested accused Ayush Kahar (20 yrs) S/O Subhash Kahar of Dharam Nagar, Coolipara, Ward No-01. PS- Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.


