(i) 80 (eighty) bottles of 60 Up Himalayan Gold India Made liquor which were kept in 04 (four) separate papers made cartoons, each bottle containing 600 ml i.e, total (80 x 600 ml) = 48 ltrs - Marked as Exhibit A, out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1" and (ii) 36 (thirty six) bottles of "TUBORG PREMIUM BEER" which were kept in 03 (three) separate paper made cartoons each bottle containing 650 ml i.e, total (36 x 650 ml) = 23.4 ltrs - Marked as Exhibit - 'B' out of which 01, bottle of the same taken each as sample for examination and marked as Exhibit "B1". (Total 48 ltrs + 23.4 ltrs = 71.4 ltrs ltrs).

Sir,

In producing herewith the following seized articles under proper seizure list viz :- (i) 80 (eighty) bottles of 60 Up Himalayan Gold India Made liquor which were kept in 04 (four) separate papers made cartoons, each bottle containing 600 ml i.e, total (80 x 600 ml) = 48 ltrs - Marked as Exhibit A, out of which one bottle of the same taken as sample for examination and marked as Exhibit "A1" and (ii) 36 (thirty six) bottles of "TUBORG PREMIUM BEER" which were kept in 03 (three) separate paper made cartoons each bottle containing 650 ml i.e, total (36 x 650 ml) = 23.4 ltrs - Marked as Exhibit - 'B' out of which 01 bottle of the same taken as sample for examination and marked as Exhibit "B1". (Total 48 ltrs + 23.4 ltrs = 71.4 ltrs ltrs). I, ASI Bikash Roy of Pradhan Nagar P.S, Siliguri Police Commissionerate would like to lodge this written complaint against accused Saheb Roy S/O Rambilash Roy of C/O Saheb Vaishnav Hotel, Coolipara Road, Siliguri Junction, PS- Pradhan Nagar, Dist.- Darjeeling to the effect that on 27.04.26 at around 19.45 hrs I received a secret source information to the effect that one person namely Saheb Roy of Coopira Road, Siliguri Junction is running illegal business illicit liquor and he storred huge quantity illegal liquor and kept the same in an abandon room situated at Coolipara Road. Accordingly, I diarized the fact in PS General Diary vide Pradhan Nagar PS GDE No 1628 dated 27.04.26 and informed the fact to you. As per your kind order and direction, myself along with SI Goutam Mallik of SB, SPC, and force left for Coolipara Road by Govt vehicle with investigation kit to verify the veracity of the information. On the way to Dharam Nagar, I informed one videographer namely Somnath Chatterjee S/O Sushil Chatterjee of Gokhel Road, Arabinda Pally, PS- Siliguri Dist. Darjeeling over mobile phone and requested him to come to Coolipara Road, Siliguri Junction with his camera for the purpose of videography if required. At around 20.05 hrs we arrived at Coolipara Road under PS Pradhan Nagar, Dist. Darjeeling and contacted with my sourec. After a while the above mentioned camera man arrived there with his camera. Then, I contacted with two independent witnesses namely Pradip Kr Ray (30 yrs) S/O Arjun Ray and (ii) Bipin Ray (27 yrs) S/O Sarwan Ray both of Rajendra Nagar, Coolipara, Ward No-01, PS- Pradhan Nagar, Dist. Darjeeling and shared the information with them and requested them to remain present at spot and act as witness if any search and seizre would be made. Upon which they agreed and expressed their willingness to co operate with me and act as independent witness. Thereafter, being pointed by the source we entered into one abandon room with both the above mentioned witnesses but nobody was available inside the room. On search the said abandon room the above noted articles are recovered from the room. I, conducted local enquiry and it could be revealed that the said room is under the possession of one Saheb Roy S/O Rambilash Roy of C/O Saheb Vaishnav Hotel, Coolipara Road, Siliguri Junction, PS- Pradhan Nagar, Dist.- Darjeeling and he is running illegal business of liquor since few months. Accordingly, I seized and labeled the above mentioned illegal illicit distilled liquor from the spot under proper seizure list in presence of above mentioned two independent witnesses. The entire process of search and seizure was made in between 20.25 hrs to 21.15 hrs. at the spot under the coverage of videography executed by the above mentioned videographer as per norms of BNSS. Further, I conducted raids in several places to secure arrest of accused Saheb Roy S/O Rambilash Roy of C/O Saheb Vaishnav Hotel, Coolipara Road, Siliguri Junction, PS- Pradhan Nagar, Dist.- Darjeeling but he is found absconding.

Under the above mentioned fact and circumstances, I therefore pray before your good self that a specific case may kindly be initiated against accused Saheb Roy S/O Rambilash Roy of C/O Saheb Vaishnav Hotel, Coolipara Road, Siliguri Junction, PS- Pradhan Nagar, Dist.- Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
