Sir,

with due respect I Rima Mukherjee wife of Souvar Mukherjee  
want to know you that we are residing at 31 APC SARANI,  
HAIDER PARA BAZAR, 734006 in rent at the house of  
SANJIT SARKAR.

On 26th April my husband Souvar Mukherjee was assaulted  
and attempt to murder by Sanjit Sarkar, Hitaishi Sarkar,  
Abhrajit Sarkar, Souvar Malakar & his brother and more  
than 10 to 15 people at 6:30 Pm. All are entered in the  
house forcefully and assault my husband. A total of  
17 stitches are in my husband head. Medical report is also  
attached.

Also the Hitaishi Sarkar charges a wrong allegation to  
my husband that he kissed her. But as per my knowledge my  
husband can't do that with anyone, the mother of Hitaishi Sarkar  
named as Mithu Roy Sarkar was also with us and she also said  
that all allegations are wrong.

I am very much afraid of the incident. Request you kindly  
do the needful and protect us
