Sub; Prayer for lodging FIR against arrested accused named Deeraj Togga (22) s/o Bishnu Tigga of Hansqua, PS Bagdogra, Dist. Darjeeling.

Sir,

With due respect, I am producing herewith 01 (One) arrested accused persons namely Deepraj Tigga (22) s/o Bishnu Tigga of Hansqua, PS Bagdogra, Dist. Darjeeling under arrest. The ground of arrest duly been communicated with him and the following articles under seizure :-

- (i) One iron made single barrel country made improcvised fire arms locally called as Deshi kotta measuring total length 24 cm having barrel length 14 cm with active one hanner, firing pin, one trigger and butt cover with wood marked as exhibit "A",
- (ii) One 7.7 mm X56mm light ammunition measuring length 7.5 cm marked as "B"

I, ASI Shekhar Lama of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted arrested accused person. In this regard, I beg to report that today i.e. on 20.04.2026 at 18.35 hrs I received a secret information that one person came to Singhijhora, under Bagdogra PS, SPC with improvised fire arms and ammunition to deliver the same to his design customer. Accordingly, I diarised the information in General diary vide BDR PS GDE No-1000 dated 20.04.2026 and informed the fact to you. As per kind order and direction myself along with ASI-Amit Lama left for Singhijhora, under Bagdogra PS, Dist. Darjeeling with investigation kit to work out the information in hand by Govt. vehicle under the leadership of SI Debabrata Kundu of Bagdogra PS SPC. On the way I contacted with evening K-35 mobile van officer ASI Gouranga Das to accompany with us at the above noted PO. Then ASI Gouranga Das along with force C/522 Anil Barman, C/1107 Pradip Roy accompanied with us. We reached at the spot Singhijhora, under Bagdogra PS, Darjeeling at about 19.05 hrs and as indicated by the source we able to apprehend one person. On being asked he disclosed his identity as noted above. As per source information, that he possesses improvised fire arms and ammunition Hence, immediately I searched the above noted detained person and found (i) 01 (One) Improvised small fire arms (ii) One live ammunition as noted above. He exclusively possessed improvised fire arm and live ammunition illegally. On demand he failed to produce any document in support the said improvised fire arm and live ammunition which has been found from his possession. On further interrogation he state that he came to Singhijhora more, PS Bagdogra, Dist. Darjeeling to deliver the same to his design customer for his wrongful gain. Thus when his involvement in carrying and possessing illegal fire arm and live ammunition was established, I seized that improvised fire arms and 01 (One) rounds of live ammunition and under proper seizure list duly signed by him as well as by available witnesses. The whole processes of seizure and lebelled was made in between 20.05 hrs to 20.30 hrs on 20.04.2026. Accordingly, I, arrested the apprehended accused person after issuing memo of arrest informing them about the ground of arrest. The process of search, seizure & arrest is done through audio-video

electronic means using DSLR camera and then the same audio-video record is converted to a pen drive using computer system.

Under the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused person namely Deepraj Tigga (22) s/o Bishnu Tigga of Hansqua, PS Bagdogra, Dist. Darjeeling is desperate and dangerous in nature, as he was carrying the said fire arm and ammunition with an objective to commit heinous crime in the locality.

As he has willfully violated the regulation of Arms Act, So, I pray before you for starting a case against the arrested accused person namely Deepraj Tigga (22) s/o Bishnu Tigga of Hansqua, PS Bagdogra, Dist. Darjeeling under appropriate section of law and arrange for its investigation.


