I am Smt Sarla, wife of Chirag Sharma, resident of Amrit Alayam\_\_\_, want to lodge a complaint against my husband and his associates as follows:

I was married to my husband about 9 years ago according to Hindu marriage rituals, since the said marriage we have one 6 years old girl child. My husband is a businessman and he has a business of sale and purchase of cycles at Hyderpara Siliguri. After the said marriage everything was fine but from the last two three years my husband is keeping illicit relationship with one Puja Paul, resident of Hakimpara Siliguri, he always used to talk to her over his mobile phone they have severely met with each other. Since the extra marital affair my husband has left to take Care of myself and my daughter, anytime he leaves the house in the night. If i raise any questions, he used to commit torture upon me both by physically and mentally, sometimes his amount of torture becomes to grave which makes me bound to take decision to commit suicide but looking at the face of my daughter I restrain myself from doing such act.

Yesterday night at about 10:15 pm we came to our house from a family function after reaching home my husband was preparing to leave home when I asked where he was supposed to go he refused to answer and started to assault me and left the house.

It is important to mention here that the brother of Puja Paul, namely Subal Paul used to threaten me that if I shall not give divorce to my husband he will kill me or abduct me by engaging hired goons.

Sir it is my kind of appeal to take appropriate legal action against my above said husband and his lover and her brother and give me justice.
