I Rohan Mech, son of Late Sahadeb Mech, aged about 49 years, resident of Salbari, P.O. Salbari, P.S. Pradhan Nagar; wish to lodge an FIR against a person known as Roshan Sah who abused and harassed me in a public place while I was driving back home in my Car Alto K10.

The Accused was fully intoxicated and blocked my path by his bike. on the The accused park his bike on the middle of the road and I told the accused to park his bike on the side of the road. Then the accused behaved aggressively, used foul and abusive language. The incident took place on 28th April 26 at 10.30pm at Gaddi Lipa, Kadi Mandir Road, Salbari.

Without any provocation, the accused took out sharp weapons and attacked to murder me.

Fortunately, local villagers who were present at the scene intervened courageously and saved me from the attackers. Without timely intervention from the villagers, the accused would have murdered me.
