SUB: REQUEST TO LODGE AN FIR FOR UNAUTHORISED ENTRY AND ILLEGAL ACTIVITES TO OBSTRUCT SMOOTH OPERATION AT OUR DAGAPUR GODOWN WHICH IS LEASED OUT TO ZIPPIEE (VENDOR OF FLIPKART) BY SUSHIL PRASAD, SON OF LALDEV PRASAD WHO IS STAYING BEHIND PORTION OF OUR DAGAPUR COMPLEX TOWARDS DEVENPORT WAREHOUSE OCCUPIED ILLEGALLY (WITHIN OUR BOUNDARY WALL).

Dear Sir,

I Shri Pradip Kumar Saha, Son of Late Bijoy Krishna Saha, resident at Patel Road, Pradhan Nagar Siliguri am like to complain as follows:-

1. That Shri Sushil Prasad, having Mobile No. 96796 51805, son of Laldev Prasad staying behind our Dagapur Complex within our boundary wall and occupied illegally, started illegal activities by breaking the glasses of Loaded/Unloaded truck and also beating my driver of Zippiee (Vendor of Flipkart) and uttered Filthy Languages by drinking alcohol at 12:00 in the midnight on 29/04/2026.
2. He has stopped the Loading and Unloading operation without any reason to earn extort money from the persons of Zippiee (Vendor of Flipkart) who are running their business (24 * 7) from our warehouse let out to them long before.
3. Further Sushil Prasad, Son of Laldev Prasad is also known as criminal against whom we have already lodged an FIR long before due to illegal occupation of our land in the same complex.
4. Now, Shri Sushil Prasad is engaged in illegal activities who is also known as criminal and extort money from the tenants of the leased out warehouses to the respective tenants. We have at least 8 (Eight) numbers of warehouses which are leased out to various multinational companies who are operating their business day and night from the said warehouses.

If this type of illegal activities goes on there, with drinking of alcohol continuously at our warehouse complex, our reputation will be badly hampered to those multinational companies.
