Sub : - F.I.R. against desperate cattle thieves.

Sir,
In producing herewith the following seized articles viz one white colour Scorpio vehicle displaying Registration number WB/54/K/6872, three ropes and one Zimmanama of one bull under proper seizure list, I ASI Biplab Kr Das of Pradhan Nagar PS lodged this written complaint against the current owner and driver and two other unknown miscreants to the effect that on 30.04.26 I along with CV/128 Ajay Kr Sahani, CV/992 Jagadish Biswas and CV/645 Pankaj Gupta all of Pradhan Nagar PS were engaged in performing night PC (plain cloth) Mobile van duty vide Pradhan Nagar PS GDE No 1783 dated 30.04.26. In course of my night patrolling duty at around 02.35 hrs we went to Sishabari area near Milan More under PS - Pradhan Nagar, Dist. Darjeeling and noticed three miscreants engaged themselves in picking up one road side cow in a Scorpio vehicle. Seeing the Police van proceeding towards them, they started to flee away from the spot. We also started to chase them. During chase approx 01 KM ahead of Milan More, suddenly the said Scorpio stopped in the middle of the road. We also stopped our vehicle. Then, the driver of the miscreant's vehicle started to move back desperately with high speed and intentionally hit our PC van which caused partial damage to our PC van. In order to save our lives we all got down from our PC van and tried to apprehend them. Then all the three culprits including driver of the Scorpio got down from their vehicle and started pelting stones on us and one stone hit on my left hand thumb. I sustained injury and suffered severe pain. Taking this advantage they managed to flee away from the spot.

Then I informed another night Van Officer - SI Gopal Ch. Mandal and requested him to come to Sishabari to assist us. After a while SI Gopal Ch Mandal and his team arrived at Sishabari. Thereafter, we searched the Scorpio and found one bull is loaded in the said Scorpio tied with a rope. Then, we unloaded the bull from the vehicle and made it free from rope. We searched for the owner of the said bull but due to odd hours of night nobody could be able to turn up before me to claim the bull. Accordingly, I seized the following articles viz :- (i) one white colour Scorpio vehicle displaying registration Number WB/54/K/6872 (ii) one small red & white colour bull (iii) three numbers of ropes under proper seizure list. Then to take care of the livestock properly, I gave it to Zimma to a local person namely Kabin Roy @ Kotai S/O Malikanta Roy of Simulguri, PS- Bhakti Nagar, Dist. Darjeeling following legal procedures. Then, I brought rest seized articles to Pradhan Nagar PS for further necessary action. Arriving at Pradhan Nagar PS, I submitted a requisition to Shri Bholanath Baruri, Mechanical Expert, Siliguri with a request to mechanically examine the seized vehicle displaying Registration No. WB/54/K/6872 which is kept at Pradhan Nagar PS Compound. Then, I went to Matigara Hospital for my medical examination.

During preliminary enquiry, I received Mechanical examination report from Shri Bhola Nath Baruri, Mechanical expert, Siliguri from where it is learnt that the Chassis number and Engine number of the said seized Scorpio vehicle having registration WB/54/K/6872 are tampered.

From the above mentioned facts and seizure of incriminating articles, there are sufficient reasons to believe that all the above mentioned miscreants are dreaded criminals involved in lifting and stealing of road side cows for selling them to their designed customers for their wrongful gain.

I, therefore, pray before your good self that a specific case under proper sections of law may kindly be initiated against the current owner and driver of the Scorpio vehicle displaying Registration number WB/54/K/6872 and other unknown miscreants and its investigation may kindly be arranged.
